Dear Senate President Kouchi and Speaker Saiki:

The University of Hawai'i Professional Assembly (UHPA) and the employer have reached an agreement concerning collective bargaining (CB) for Unit 7 (Faculty of the University of Hawai'i). Notification of ratification of the CB agreement was issued on April 8, 2022. In accordance with Section 89-10(b), cost items must be submitted to the Legislature for appropriation. The following summary of the included and excluded requirements of the settlement for the current fiscal biennium is being transmitted to the Legislature for authorization:

- 7 SECTION 6. The fiscal year 2021-2022 appropriations or
- 8 authorizations under this Act shall not lapse until the end of
- 9 fiscal biennium 2021-2023; provided that funds appropriated or
- 10 authorized by this Act that are not expended or encumbered by
- June 30, 2023, shall lapse as of that date.
