# A BILL FOR AN ACT

RELATING TO THE STATE BUDGET.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I. GENERAL PROVISIONS
SECTION 1. SHORT TITLE. This Act shall be known and may
be cited as the General Improvements Act of 2021.
SECTION 2. DEFINITIONS. Unless otherwise clear from the
context, as used in this Act:
"Expending agency" means the executive department,
independent commission, bureau, office, board, or other
establishment of the state government (other than the
legislature, office of Hawaiian affairs, and judiciary), the
political subdivisions of the State, or any quasi-public
institution supported in whole or in part by state funds, which
is authorized to expend specified appropriations made by this
Act.
Abbreviations, where used to denote the expending agency,
shall mean the following:

#### PART II. PROGRAM APPROPRIATIONS

11 SECTION 3. APPROPRIATIONS. The following sums, or so much 12 thereof as may be sufficient to accomplish the purposes and 13 programs designated herein, are hereby appropriated or 14 authorized, as the case may be, from the means of financing 15 specified to the expending agencies designated for the fiscal 16 biennium beginning July 1, 2021, and ending June 30, 2023. The 17 total expenditures and the number of positions in each fiscal 18 year of the biennium shall not exceed the sums and the position 19 ceilings indicated for each fiscal year, except as provided 20 elsewhere in this Act or as provided by general law.



2 SECTION 6. AIRPORT REVENUE BONDS. #### PART VII. MISCELLANEOUS AND EFFECTIVE DATE

SECTION 31. If any portion of this Act or its application 8 9 to any person, entity, or circumstance is held to be invalid for 10 any reason, the legislature declares that the remainder of the Act and each and every other provision thereof shall not be 11 12 affected thereby. If any portion of a specific appropriation is 13 held to be invalid for any reason, the remaining portion shall 14 be expended to fulfill the objective of the appropriation to the extent possible. 15

16 SECTION 32. If manifest clerical, typographical, or other 17 mechanical errors are found in this Act, the governor is hereby 18 authorized to correct the errors.
