A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE VIII, SECTION 3 OF THE HAWAII CONSTITUTION RELATING TO THE FUNCTIONS, POWERS, AND DUTIES OF REAL PROPERTY TAXATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has one of
- 2 the highest income tax rates and the lowest real property tax
- 3 rates in the nation. These tax strategies result in a
- 4 disproportionate amount of the overall tax burden being placed
- 5 on the residential workforce, who, in turn, effectively
- 6 subsidize non-residents' real estate investments in Hawaii.
- 7 The legislature further finds that removing the exclusivity
- 8 of county authority over real property taxes will provide the
- 9 State with greater flexibility and control of its taxation
- 10 policies.
- 11 The intention is to ultimately eliminate personal and
- 12 business income taxes and offset these tax revenue sources with
- 13 real property taxes. The legislature intends to double the
- 14 homeowner and senior exemptions on real property taxes to lessen
- 15 the overall tax burden on local residents. If this Act is
- 16 enacted and the amendment to the Hawaii State Constitution is

- 1 ratified, House Bill No. 1209, House Draft 2, Regular Session of
- 2 2022, upon its enactment and the enactment of state law
- 3 specifying the real property tax amounts to be levied and
- 4 assessed, will take effect and the State will stop collecting
- 5 all income taxes.
- 6 The purpose of this Act is to propose an amendment to
- 7 article VIII, section 3, of the Constitution of the State of
- 8 Hawaii to repeal the exclusive authority of the counties to
- 9 exercise the functions, powers, and duties of real property
- 10 taxation, and thereby authorizing the State to also exercise
- 11 those functions, powers, and duties.
- 12 SECTION 2. Article VIII, section 3, of the Constitution of
- 13 the State of Hawaii is amended to read as follows:
- 14 "TAXATION AND FINANCE
- 15 Section 3. The taxing power shall be reserved to the
- 16 State, except so much thereof as may be delegated by the
- 17 legislature to the political subdivisions, and except that [all]
- 18 functions, powers and duties relating to the taxation of real
- 19 property [shall] may be exercised [exclusively] by the counties,
- 20 with the exception of the county of Kalawao. The legislature

- 1 shall have the power to apportion state revenues among the
- 2 several political subdivisions."
- 3 SECTION 3. The question to be printed on the ballot shall
- 4 be as follows:
- 5 "Shall the Hawaii State Constitution be amended to repeal
- 6 the counties' exclusive authority to exercise functions, powers,
- 7 and duties relating to the taxation of real property, thereby
- 8 authorizing both the State and counties to exercise functions,
- 9 powers, and duties relating to the taxation of real property?"
- 10 SECTION 4. Constitutional material to be repealed is
- 11 bracketed and stricken. New constitutional material is
- 12 underscored.
- SECTION 5. This amendment shall take effect on July 1,
- 14 2050; provided that this amendment shall take effect upon
- 15 compliance with article XVII, section 3, of the Constitution of
- 16 the State of Hawaii.
