A BILL FOR AN ACT

RELATING TO THE STADIUM DEVELOPMENT DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 109-1, Hawaii Revised Statutes, is
2	amended by amending subsections (a) and (b) to read as follows:
3	"(a) There shall be within the department of accounting
4	and general services for administrative purposes only, a stadium
5	authority whose responsibility shall be to maintain, operate,
6	and manage the stadium development district. The authority
7	shall consist of [eleven] thirteen members. Eleven members
8	[who] shall be appointed by the governor in the manner
9	prescribed by section 26-34.
10	Of the eleven appointed members:
11	(1) One member shall be designated as the Aiea community
12	representative and be a resident of one of the
13	following areas:
14	(A) Excluding Ford Island, the area beginning at the
15	intersection of the shoreline and Admiral Clarey
16	(Ford Island) Bridge and running:

4	(I)	Southerly along said drive to Puolo drive;

6	(K)	Southerly along said street to Maluna street;
7	(L)	Westerly along said street to Salt Lake
8		boulevard;
9	(M)	Southeasterly along said boulevard to the former
10		street entrance to U.S. Naval Reservation;
11	(N)	Southwesterly along said feature to Reeves loop;
12	(0)	Southwesterly along said loop to Radford drive;
13	(P)	Westerly along said drive to H-1 freeway; and
14	(Q)	Northerly along said freeway to its intersection
15		with Moanalua freeway (H-201).
16	Each member of	f the authority shall have been a citizen of the
17	United States	and a resident of the State for at least five
18	years next pro	eceding the member's appointment. The [eleven
19	members shall	include] remaining two members shall be the
20	president of	the University of Hawaii and the superintendent of

1	education, who shall [be] serve as ex officio nonvoting members
2	of the authority [but shall not vote].
3	(b) The chairperson of the authority shall be elected by
4	the majority of the members of the authority. The term of each
5	member shall be four years; provided that:
6	(1) Of the members initially appointed, three members
7	shall serve for four years, three members shall serve
8	for three years, and the remaining three members shal
9	serve for two years; and
10	(2) The terms of the members added by [Act 146, Session
11	Laws of Hawaii 2021, Act , Session Laws of Hawaii
12	2022, shall commence on July 1, [2021 .] 2022 .
13	No person shall be appointed consecutively to more than two
14	terms as a member of the authority. Vacancies shall be filled
15	for the remainder of any unexpired term in the same manner as
16	original appointments."
17	SECTION 2. Statutory material to be repealed is bracketed
18	and stricken. New statutory material is underscored.
19	SECTION 3. This Act shall take effect upon its approval.
