A BILL FOR AN ACT

RELATING TO THE STADIUM DEVELOPMENT DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 109-1, Hawaii Revised Statutes, is
2	amended by amending subsections (a) and (b) to read as follows:
3	"(a) There shall be within the department of accounting
4	and general services for administrative purposes only, a stadium
5	authority whose responsibility shall be to maintain, operate,
6	and manage the stadium development district. The authority
7	shall consist of [eleven] thirteen members. Eleven members
8	$[\frac{who}{c}]$ shall be appointed by the governor in the manner
9	prescribed by section 26-34.

11	(1) One member shall be designated as the Aiea community

- 1 the superintendent of education, who shall [be] serve as ex
- 2 officio nonvoting members of the authority [but shall not vote].
- 3 (b) The chairperson of the authority shall be elected by
- 4 the majority of the members of the authority. The term of each
- 5 member shall be four years; provided that:
- 6 (1) Of the members initially appointed, three members
- 7 shall serve for four years, three members shall serve
- 8 for three years, and the remaining three members shall
- 9 serve for two years; and
- 10 (2) The terms of the members added by [Act 146, Session
- 11 Laws of Hawaii 2021, Act , Session Laws of Hawaii
- 12 2022, shall commence on July 1, [2021.] 2022.
- 13 No person shall be appointed consecutively to more than two
- 14 terms as a member of the authority. Vacancies shall be filled
- 15 for the remainder of any unexpired term in the same manner as
- 16 original appointments."
- 17 SECTION 2. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 3. This Act shall take effect on July 1, 2050.
