#### A BILL FOR AN ACT

RELATING TO A SEX TRAFFICKING EMERGENCY SHELTER.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sex trafficking is a
- 2 modern-day form of slavery. According to a September 2018
- 3 report published by Arizona State University and the Hawaii
- 4 state commission on the status of women, it is estimated that
- 5 one out of every eleven men in Hawaii over the age of eighteen
- 6 is an online sex buyer and that there are 74,362 potential sex
- 7 buyers in Hawaii. Moreover, during the coronavirus disease 2019
- 8 (COVID-19) pandemic, a service provider for sex trafficking
- 9 victims in Hawaii reported seeing a three hundred per cent
- 10 increase in demand for services, which included trauma-informed
- 11 care.
- In 2018, as a part of a juvenile justice reform measure,
- 13 the legislature authorized the creation and development of the
- 14 Kawailoa youth and family wellness center at the site of the
- 15 Hawaii youth correctional facilities, including "crisis shelters
- 16 for victims of human and sex trafficking" under section
- 17 352D-7.5(d), Hawaii Revised Statutes. Within a few months of



- 1 that authorization, the Kawailoa campus included an assessment
- 2 center and shelter for young victims of sex trafficking. In
- 3 addition, in the spring of 2021, Hoʻola Na Pua opened a
- 4 first-of-its-kind, thirty-two bed, residential treatment program
- 5 for victims of sex trafficking in Hawaii.
- 6 The legislature further finds that, despite the development
- 7 of these two much-needed facilities, a gap in service remains
- 8 that can be met by an emergency shelter for minor victims of sex
- 9 trafficking. An emergency shelter for minor victims of sex
- 10 trafficking would improve the State's effectiveness in
- 11 responding to sexual exploitation by allowing government
- 12 agencies and victim service providers to establish a coordinated
- 13 continuum of care and protect victims in a centralized location.
- 14 Accordingly, the purpose of this Act is to authorize the
- 15 department of human services to establish or contract with a
- 16 victim service provider to operate an emergency shelter for
- 17 minors who are victims of sex trafficking and sexual
- 18 exploitation.
- 19 SECTION 2. Chapter 237, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated
- 21 and to read as follows:

1	"§237- Exemption for victim service providers of sex
2	trafficking emergency shelters for minors. There shall be
3	exempted from the measure of all taxes imposed by this chapter
4	any compensation received by a victim service provider for
5	operating or managing a sex trafficking emergency shelter for
6	minors pursuant to section 346"
7	SECTION 3. Chapter 346, Hawaii Revised Statutes, is
8	amended by adding a new section to part I to be appropriately
9	designated and to read as follows:
10	"§346- Sex trafficking emergency shelter for minors.
11	(a) The department may establish or contract with a victim
12	service provider to operate an emergency shelter for sex
13	trafficking victims.
14	(b) The emergency shelter shall provide emergency services
15	to sex trafficking victims granted admittance to the shelter.
16	Emergency services shall include but not be limited to housing,
17	rehabilitation, medical, mental health, therapeutic, legal, and
18	diagnostic services.
19	(c) The operator of the emergency shelter, in consultation
20	with any appropriate governmental agency or nongovernmental
21	organization, shall be responsible for determining:

1	(1)	If a sex trafficking victim is eligible for services
2		at the shelter, including the level of need and course
3		of treatment for each victim; and
4	(2)	Whether a sex trafficking victim is no longer eligible
5		for services at the shelter; provided that services
6		for any victim shall not exceed thirty days.
7	(d)	Any person who enters or remains on the premises of an
8	emergency	shelter authorized by this section after being asked
9	to leave	by the department or its designee, a victim service
10	provider,	or a law enforcement officer shall be guilty of a
11	misdemean	or.
12	<u>(e)</u>	Any compensation received by a victim service provider
13	for opera	ting or managing an emergency shelter pursuant to this
14	section s	hall be exempt from taxation under chapter 237.
15	<u>(f)</u>	The mayor of any county in the State, by executive
16	order, ma	y exempt the operator of an emergency shelter
17	establish	ed pursuant to this section from real property taxes,
18	water and	sewer development fees, rates collected for water
19	supplied	to consumers and for use of sewers, and any other
20	county ta	xes, charges, rates, or fees arising from the operation
21	of the se	x trafficking emergency shelter; provided that any

2	authorized by this section.
3	
3	(g) The department shall require any victim service
4	provider with whom it enters into a contract under this section
5	to submit to the department a report for each year that the
6	contract is in effect. The report shall include a financial
7	report and recommendations for improving services for sex
8	trafficking victims. Failure to provide the required report
9	shall be grounds for the department to terminate a contract with
10	the victim service provider.
11	(h) Nothing in this section shall prohibit the department
12	from establishing additional programs or services for sex
13	trafficking victims.
14	(i) As used in this section:
15	"Minor" means a person who is less than eighteen years of
16	age.
17	"Sex trafficking victim" means:
18	(1) A minor subject to an act or practice of prostitution
19	as described in section 712-1200;
20	(2) A minor subject to an act or practice of sex
21	trafficking, as described in section 712-1202(b);

1	<u>(3)</u>	A minor who is a victim of the offense of promoting
2		prostitution under section 712-1203;
3	(4)	A minor solicited for prostitution, as described in
4		section 712-1209.1;
5	<u>(5)</u>	A victim of a severe form of trafficking, as defined
6		in title 22 United States Code section 7102, who is a
7		<pre>minor;</pre>
8	(6)	A victim of trafficking, as defined in title 22 United
9		States Code section 7102, who is a minor; or
10	<u>(7)</u>	A minor subject to the crime of sex trafficking of
11		children or by force, fraud, or coercion under title
12		18 United States Code section 1591.
13	"Vic	tim service provider" means a nonprofit or
14	nongovern	mental organization that provides services to sex
15	trafficki	ng victims, including outreach, direct intervention,
16	housing,	rehabilitation, education, vocational, medical, mental
17	health, o	r substance abuse treatment programs."
18	SECT	ION 4. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$500,000 or so much
20	thereof a	s may be necessary for fiscal year 2022-2023 for the
21	departmen	t of human services to establish or contract with a
