### A BILL FOR AN ACT

RELATING TO GIFTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 84-11, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "§84-11 Gifts[-]; exceptions. (a) No legislator or
- 4 employee shall solicit, accept, or receive, directly or
- 5 indirectly, any gift, whether in the form of money, service,
- 6 loan, travel, entertainment, hospitality, thing, or promise, or
- 7 in any other form, under circumstances in which it can
- 8 reasonably be inferred that the gift is intended to influence
- 9 the legislator or employee in the performance of the
- 10 legislator's or employee's official duties or is intended as a
- 11 reward for any official action on the legislator's or employee's
- 12 part[-]; provided that the unsolicited acceptance or receipt of
- 13 the following gifts shall not be prohibited pursuant to this
- 14 section:
- 15 (1) Foreign protocol gifts;
- 16 (2) Gifts of aloha;

5	aloha or	appreciation that are:
6	(1)	Of a perishable nature, including manapua, malasada,
7		plate lunches, bento, and other raw or prepared food,
8		lei made of flowers or seeds, and other flower
9		arrangements, with a fair market value of
10		<pre>\$ or less, singularly or in the aggregate;</pre>
11	`	and
12	(2)	Of a durable nature, offered to a legislator or
13		employee to honor the legislator or employee,
14		including plaques; framed certificates, drawings, and
15		photographs; and other ceremonial items that do not
16		have resale value."
17	SECT	TON 2. If any provision of this Act, or the
18	application thereof to any person or circumstance, is held	
19	invalid,	the invalidity does not affect other provisions or
20	applicati	ons of the Act that can be given effect without the

- 2 of this Act are severable.
- 3 SECTION 3. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
