

#### A BILL FOR AN ACT

RELATING TO THE SUNSHINE LAW.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the people hold the
- 2 ultimate decision-making power in our representative democracy.
- 3 This may only be accomplished when governmental agencies, boards
- 4 and commissions, and county councils allow for meaningful public
- 5 input and embrace the public as a true collaborative partner in
- 6 policymaking and governance. A robust sunshine law is necessary
- 7 to opening up the governmental processes to public scrutiny and
- 8 participation to achieve the ideals of a representative
- 9 democracy.
- 10 The purpose of this Act is to strengthen the State's
- 11 sunshine law to provide the public with more oversight of
- 12 governmental agencies, boards and commissions, and county
- 13 councils and to allow the public to give more meaningful,
- 14 contemporaneous testimony at properly agendized meetings.
- 15 SECTION 2. Section 92-3, Hawaii Revised Statutes, is
- 16 amended to read as follows:

1	"§92-3 Open meetings[-]; recording requirements. (a)
2	Every meeting of all boards shall be open to the public and all
3	persons shall be permitted to attend any meeting unless
4	otherwise provided in the constitution or as closed pursuant to
5	sections 92-4 and 92-5; provided that the removal of any person
6	or persons who wilfully disrupts a meeting to prevent and
7	compromise the conduct of the meeting shall not be prohibited.
8	The boards shall afford all interested persons an opportunity to
9	submit data, views, or arguments, in writing, on any agenda
10	item. The boards shall also afford all interested persons an
11	opportunity to present oral testimony on any agenda item $[-]$ and
12	shall allow for oral testimony after each agenda item. The
13	boards may provide for reasonable administration of oral
14	testimony by rule.
15	(b) Every meeting of all boards shall be livestreamed
16	through the use of audiovisual or audio technology. The
17	recording of each meeting shall be archived and made available
18	to the public on the board's website or, if the board does not
19	have a website, on an appropriate state or county website
20	immediately after the meeting."

         SECTION 3. Section 92-7, Hawaii Revised Statutes, is

    amended by amending subsections (a) and (b) to read as follows:

               The board shall give written public notice of any

    regular, special, emergency, or rescheduled meeting, or any

    executive meeting when anticipated in advance. The notice shall

    include an agenda that lists all of the items to be considered

    at the forthcoming meeting[;] and shall identify each item on

    the agenda as an item for action, in which board members shall
9
    take action upon the item, or an item for discussion, in which
10
    board members shall only discuss the item; the date, time, and
11
    place of the meeting; instructions on how to request an

    auxiliary aid or service or an accommodation due to a

    disability, including a response deadline, if one is provided,

    that is reasonable; and in the case of an executive meeting, the

    purpose shall be stated. If an item to be considered is the

    proposed adoption, amendment, or repeal of administrative rules,

    an agenda meets the requirements for public notice pursuant to

    this section if it contains a statement on the topic of the

    proposed rules or a general description of the subjects

    involved, as described in section 91-3(a)(1)(A), and a statement

- 2 specified by this section shall be the only means required for
- 3 giving notice under this part notwithstanding any law to the
- 4 contrary.
- 5 (b) No less than six calendar days prior to the meeting,
- 6 the board shall post the notice online on an electronic calendar
- 7 [on] via a link on the homepage of a website maintained by the
- 8 State or the appropriate county [and post a notice in the
- 9 board's office] for public inspection. The notice shall also be
- 10 posted at the site of the meeting whenever feasible. The board
- 11 shall file a copy of the notice with the office of the
- 12 lieutenant governor or the appropriate county clerk's office and
- 13 retain a copy of proof of filing the notice, and the office of
- 14 the lieutenant governor or the appropriate clerk's office shall
- 15 timely post paper or electronic copies of all meeting notices in
- 16 a central location in a public building; provided that a failure
- 17 to do so by the board, the office of the lieutenant governor, or
- 18 the appropriate county clerk's office shall not require
- 19 cancellation of the meeting. The copy of the notice to be
- 20 provided to the office of the lieutenant governor or the
- 21 appropriate county clerk's office may be provided via electronic

1 mail to an electronic mail address designated by the office of 2 the lieutenant governor or the appropriate county clerk's 3 office, as applicable." 4 SECTION 4. Section 92-7.5, Hawaii Revised Statutes, is 5 amended to read as follows: 6 "[+]\$92-7.5[+] Board packet; filing; public inspection; 7 notice. [At the time the board packet is distributed to the 8 board members, the] The board shall [also] make the board packet 9 available for all board members and available for public **10** inspection in the board's office [-] and via a link on the 11 homepage of the board's website or, if the board does not have a 12 website, on an appropriate state or county website at least 13 forty-eight hours prior to the written testimony deadline. 14 board shall provide notice to persons requesting notification of 15 meetings pursuant to section 92-7(e) that the board packet is 16 available for inspection in the board's office and via a link on 17 the homepage of the board's website or appropriate state or 18 county website, and shall provide reasonably prompt access to 19 the board packet to any person upon request. The board [is]20 shall not be required to mail board packets. As soon as 21 practicable, the board shall accommodate requests [for

1 electronic access to the board packet.] from persons with 2 disabilities. 3 For purposes of this section, "board packet" means 4 documents that are compiled by the board and distributed to 5 board members before a meeting for use at that meeting, to the 6 extent the documents are public under chapter 92F; provided that 7 this section shall not require disclosure of executive session 8 minutes, license applications, or other records for which the 9 board cannot reasonably complete its redaction of nonpublic 10 information in the time available before the public inspection required by this section." 11 12 SECTION 5. Section 92-9, Hawaii Revised Statutes, is 13 amended to read as follows: 14 "§92-9 Minutes. (a) The board shall keep written or 15 recorded minutes of all meetings. [Unless otherwise required by 16 law, neither a full transcript nor a recording of the meeting is 17 required, but the] The minutes shall give a true reflection of 18 the matters discussed at the meeting and the views of the

- made by the board; and
- 12 (4) A time stamp or other reference indicating when in the
- recording the board began discussion of each agenda
- 14 item and when motions and votes were made by the
- board.
- 16 [(c)] (d) All or any part of a meeting of a board may be
- 17 recorded by any person in attendance by any means of
- 18 reproduction, except when a meeting is closed pursuant to
- 19 section 92-4; provided the recording does not actively interfere
- 20 with the conduct of the meeting."

#### Report Title:

Sunshine Law; Livestream; Oral Testimony; Board Packets; Meeting Agenda; Minutes; Online Posting

#### Description:

Requires all boards to livestream meetings and archive the recordings online. Requires a board to identify each item on its meeting agenda as an item for action or an item for discussion and allow for oral testimony after each agenda item. Amends time frame requirements for the posting of board meeting minutes and board packets. Requires board meeting minutes and board packets to be posted online.
