

#### A BILL FOR AN ACT

RELATING TO HEALTH INSURANCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 431, Hawaii Revised Statutes, is
2	amended by adding a new section to article 10A, part I, to be
3	appropriately designated and to read as follows:
4	"§431:10A- Annual mental health wellness examination
5	coverage. (a) Each individual and group policy of accident and
6	health or sickness insurance issued or renewed in this State
7	after December 31, 2022, except for policies that only provide
8	coverage for a specified disease or other limited benefit
9	coverage as described in section 431:10A-607, shall provide
10	coverage for an annual mental health wellness examination.
11	(b) The coverage required by this section shall include ar
12	annual mental health wellness examination of up to sixty minutes
13	that is performed by a qualified mental health care provider.
14	The coverage for an annual mental health wellness examination
15	shall not be less extensive than the coverage provided for a

physical examination and shall comply with all requirements of

the federal Mental Health Parity and Addition Equity Act.

3	SECTION 2. Chapter 432, Hawaii Revised Statutes, is
4	amended by adding a new section to article I to be appropriately
5	designated and to read as follows:
6	"§432:1- Annual mental health wellness examination
7	coverage. (a) Each individual or group hospital or medical
8	service plan contract issued or renewed in this State after
9	December 31, 2022, shall provide coverage for an annual mental
10	health wellness examination.
11	(b) The coverage required by this section shall include an
12	annual mental health wellness examination of up to sixty minutes
13	that is performed by a qualified mental health care provider.
14	The coverage for an annual mental health wellness examination
15	shall not be less extensive than the coverage provided for a
16	physical examination and shall comply with all requirements of
17	the federal Mental Health Parity and Addition Equity Act.
18	(c) The mental health wellness examination required by
19	this section shall be exempt from any deductible or copayment
20	provisions that may be in force in any contract. Each mutual
21	benefit society shall reimburse all costs associated with the

1	coverage	required by this section to any qualified mental health
2	care prov	ider complying with this section.
3	(d)	For purposes of this section:
4	"Men	tal health wellness examination" means an examination

19	SECT	ION 3. Section 432D-23, Hawaii Revised Statutes, is
20	amended t	o read as follows:

- 1 "§432D-23 Required provisions and benefits.
- 2 Notwithstanding any provision of law to the contrary, each
- 3 policy, contract, plan, or agreement issued in the State after
- 4 January 1, 1995, by health maintenance organizations pursuant to
- 5 this chapter, shall include benefits provided in sections
- 6 431:10-212, 431:10A-115, 431:10A-115.5, 431:10A-116, 431:10A-
- 7 116.2, 431:10A-116.5, 431:10A-116.6, 431:10A-119, 431:10A-120,
- **8** 431:10A-121, 431:10A-122, 431:10A-125, 431:10A-126, 431:10A-132,
- 9 431:10A-133, 431:10A-134, 431:10A-140, [and 431:10A-134,]
- 10 431:10A- , and chapter 431M."
- 11 SECTION 4. The benefit to be provided by health
- 12 maintenance organizations corresponding to the benefit provided
- 13 under sections 431:10A- , Hawaii Revised Statutes, as contained
- 14 in the amendment to section 432D-23, Hawaii Revised Statutes, in
- 15 section 3 of this Act, shall take effect for all policies,
- 16 contracts, plans, or agreements issued in the State after
- 17 December 31, 2022.
- 18 SECTION 5. The coverage required under sections 1, 2, and
- 19 3 of this Act shall apply to all plans under medicaid managed
- 20 care programs in the State.

- 1 SECTION 6. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 7. This Act shall take effect on July 1, 2022;
- 4 provided that sections 1, 2, and 3 shall apply to all policies,
- 5 contracts, plans, or agreements issued or renewed in the State
- 6 after December 31, 2022; provided further that section 5 shall
- 7 take effect upon approval of the Hawaii medicaid state plan by

8 the Centers for Medicare and Medicaid Services.
