BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The registrature rinus that professionar

9	SECTION 2. There is appropriated out of the general
10	revenues of the State of Hawaii the sum of \$16,600,000 or so
11	much thereof as may be necessary for fiscal year 2022-2023 for
12	twenty-one hours of professional development for teachers.
13	The sums appropriated shall be expended by the department
14	of education.
15	SECTION 3. This Act shall take effect upon its approval.

PURPOSE:

The purpose of this Act is to provide funds

JUSTIFICATION:

The purpose of this Act is to provide funds for twenty-one additional hours of professional development for teachers.

Professional development is a key component to ensuring teachers have access to the best, research-based educational practices for their classrooms. In particular, jobembedded professional development can prove to be more effective than stand-alone training sessions.

In the collectively-bargained agreement between the Hawaii State Board of Education and the Hawaii State Teachers Association that expired on June 30, 2021, there was a memorandum of understanding between the Hawaii State Board of Education and the Hawaii State Teachers Association that allowed for twenty-one additional hours to be added to the teachers' workday without students. Those twenty-one hours were to be used for job-embedded professional development to provide benefits, including a formalized structure for organizing training and learning time, reducing the need for substitute teachers, and eliminating teacher absences from classes for training. However, the memorandum of understanding expired on June 30, 2021, and because

funding was not available, the memorandum of understanding was not renewed.

Impact on the public: The public benefits by having teachers that are highly trained and qualified. Professional development allows teachers to receive the necessary training to ensure they are using the most recent, research-based teaching strategies in their classrooms.

Impact on the department and other agencies:
The Department of Education would need the funding to pay for the twenty-one additional professional development hours. The department of education would also need to negotiate with the Hawaii State Teachers
Association to create the appropriate memorandum of understanding to allow for the additional hours of professional development.
