BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for

FOR LEAD ABATEMENT.

PURPOSE:

To provide funds for lead abatement measures to repair or replace plumbing fixtures shown to have more than five parts per billion lead at Department of Education elementary

schools.

MEANS:

Provides an emergency appropriation of general funds to the Department of Education.

JUSTIFICATION:

According to the United States Environmental Protection Agency, there is no known safe level of lead in a child's blood and lead is harmful to health, especially for children.

Results of the recently completed first phase of a United States Environmental Protection Agency's, Water Infrastructure Improvements for the Nation Act grant programs found that at one hundred six Department of Education elementary schools, five per cent of drinking water sources exceeded the project action level of fifteen parts per billion lead while nearly twenty per cent exceeded five parts per billion lead.

Funding provided through this measure would be used to repair or replace plumbing fixtures shown to have more than five parts per billion lead at Department of Education elementary schools to provide safe drinking water to elementary school students.

Impact on the public: Increases the safety
of elementary school campuses by reducing

the exposure of students to levels of lead in their drinking water.

Impact on the department and other agencies: The Department of Education would need the funding to replace the problematic fixtures.
