# A BILL FOR AN ACT

RELATING TO MARRIAGE LICENSES.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that Act 211, Session 2 Laws of Hawaii 2021, authorized the issuance of a civil license to solemnize marriages. Before enactment, only individuals with 3 religious affiliations or judicial appointments could obtain a 4 5 license to solemnize marriages. Act 211, Session Laws of Hawaii 2021, also established fees 6 7 for a civil license to solemnize marriages, the intent of which 8 was to enhance general revenues from approximately twenty 9 thousand marriages per year, two-thirds of which are for out-of-10 state and international couples. However, there are no fees for 11 licenses to solemnize marriages for religious and judicial 12 marriage solemnizers. 13 The purpose of this Act is to: 14 (1)Establish a \$25 fee for all licenses to solemnize a 15 marriage to be deposited into the general fund; 16 (2) Allow the department of health to increase the fee,

1 (3) Require the department of health to account for the 2 collection and deposit of the fee into the general 3 fund; and 4 (4) Repeal the expiration of and fees specific to civil 5 licenses to solemnize marriages. 6 SECTION 2. Section 572-11, Hawaii Revised Statutes, is amended to read as follows: 7 8 "§572-11 Marriage ceremony; license to solemnize[-]; fees. 9 (a) It shall not be lawful for any person to perform the 10 marriage ceremony within the State without first obtaining from 11 the department of health a license to solemnize marriages. 12 (b) The fee for any license to solemnize a marriage shall 13 be \$25 per year to be deposited into the general fund. 14 (c) The department of health may increase the fee established under subsection (b) in accordance with chapter 91; 15 16 provided that the department of health may increase the fee up 17 to ten per cent each year without being subject to chapter 91. 18 In establishing a fee, the amount shall be sufficient to cover 19 the expenses of maintaining, improving, and modernizing the 20 issuance of licenses to solemnize marriages.

2	fees collected and deposited into the general fund pursuant to

4	SECTION 3. Section 572-12, Hawaii Revised Statutes, is
5	amended by amending subsection (b) to read as follows:
6	"(b) A civil license to solemnize marriages may be issued
7	to, and the marriage rite may be performed and solemnized by,
8	any individual at least eighteen years of age, upon presentation
9	to the individual of a license to marry, as prescribed by this
10	chapter. An individual with a civil license to solemnize a
11	marriage may receive the price stipulated by the parties or any
12	gratuity tendered. [The civil license shall be valid for no
13	less than two years from the date of its issuance; provided that
14	a temporary three-month civil license may be issued upon an
15	individual's request. The fee for a civil license shall be \$100
16	per year the permit is valid; provided that the fee for a
17	temporary three-month license shall be \$25.] An individual who
18	performs a solemnization of a marriage pursuant to a civil
19	license issued under this subsection shall obtain the prior
20	written consent of each person for whom a solemnization is

performed and fulfill all provisions of sections 572-13 and
572-15 applicable to persons authorized to solemnize marriages."
SECTION 4. Statutory material to be repealed is bracketed
and stricken. New statutory material is underscored.
SECTION 5. This Act shall take effect upon its approval.

Report Title: Marriage; License to Solemnize; Fees

#### Description:

Establishes a fee for all licenses to solemnize a marriage. Allows DOH to increase the fee, subject to certain requirements. Requires DOH to account for the collection and deposit of the fee. Repeals the expiration of and fees specific to civil licenses to solemnize marriages. (HD1)
