A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 88, Session Laws of Hawaii 2021, provided
- 5 \$15,000,000 in highways special funds for the highways
- 6 division's special maintenance program in fiscal year 2021-2022.
- 7 This Act will increase the total to \$35,000,000 for the special
- 8 maintenance program in fiscal year 2021-2022. The highways
- 9 division's special maintenance program is to preserve the
- 10 initial capital investment and to prolong the life of the
- 11 facility. Traffic, weather, and age are the major causes of the
- 12 facility deterioration. The special maintenance program is a
- 13 systematic maintenance program to prevent further and
- 14 accelerated deterioration of the highway facility. The intent
- 15 of the special maintenance program is to avoid major repairs and
- 16 to minimize routine maintenance costs. Since the closing of the
- 17 2021 regular session, the state highway fund balance is

- 1 projected to be greater than anticipated due to passage of Act
- 2 237, Session Laws of Hawaii 2021, that increases the rental
- 3 motor vehicle surcharge tax each year by \$0.50 from January 1,
- 4 2022, to December 31, 2027; the state highway fund receiving
- 5 federal funds of \$42,000,000 from the Coronavirus Response and
- 6 Relief Supplemental Appropriations Act, 2021; and the better

- 8 of this Act is to make an emergency appropriation to the
- 9 department of transportation to authorize additional funding for
- 10 the highways division's special maintenance program.
- 11 SECTION 3. There is appropriated out of the state highway
- 12 fund the sum of \$20,000,000 or so much thereof as may be
- 13 necessary for fiscal year 2021-2022 for the department of
- 14 transportation to provide funding for highways division's
- 15 special maintenance program. The sum appropriated shall be
- 16 expended by the department of transportation for the purposes of
- 17 this Act; provided further that the funds appropriated shall not
- 18 lapse at the end of the fiscal year for which it was
- 19 appropriated, but any unencumbered funds remaining shall lapse
- 20 on June 30, 2023.

TITLE:

A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION FOR THE DEPARTMENT OF

TRANSPORTATION.

PURPOSE:

To appropriate an additional \$20,000,000 for fiscal year 2021-2022 to increase the highways special maintenance program funding.

MEANS:

Appropriate special fund revenue in the sum of \$20,000,000 for fiscal year 2021-2022.

JUSTIFICATION:

The purpose of this bill is to increase the funding for the highways special maintenance program from \$15,000,000 to \$35,000,000 for fiscal year 2021-2022. The special maintenance program is a systematic maintenance program to prevent further and accelerated deterioration of highway facilities. The intent of the program is to avoid major repairs and to minimize routine maintenance costs.

Since the close of the 2021 regular session, the state highway fund balance is now projected to be greater than anticipated due to several factors. First, the passage of Act 237, Session Laws of Hawaii 2021, increases the rental motor vehicle surcharge tax each year by \$0.50 from January 1, 2022, to December 31, 2027, to be deposited into highways special fund. Second, the state highway fund will be receiving \$42,000,000 in federal funds from the Coronavirus Response and Relief Supplemental Appropriations Act passed in 2021. Finally, a much better than projected State of Hawaii economic recovery is expected in the upcoming year.

H.B. No. 2184

Impact on the public: This bill will provide additional highway special maintenance and repair projects that includes improved road conditions for motorists. In addition, the additional funding will further stimulate the economy with additional projects and increase the state's economic recovery from the Covid's effect on the State.

Impact on the department and other agencies: This bill will allow the highways division to expend additional funds on more programmed projects that were delayed by its previous limited funding on the program.
