# A BILL FOR AN ACT

RELATING TO LAND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to facilitate the
- 2 development of affordable housing for teachers on a parcel
- 3 located in Ewa Beach on the island of Oahu.
- 4 SECTION 2. (a) The State may acquire the fee simple
- 5 interest, a lease, or another form of interest in the parcel of
- 6 real property identified as TMK (1) 9-1-102-027-0000, located in
- 7 Ewa Beach on the island of Oahu, for the purpose of developing
- 8 affordable housing or facilitating the development of affordable
- 9 housing with a priority given at that location to department of
- 10 education classroom teachers in the beginning of their careers.
- 11 (b) Notwithstanding any other law to the contrary, in
- 12 addition to any moneys appropriated for the sale, lease, or
- 13 other form of acquisition, the State may offer to the seller or
- 14 lessor of the parcel:
- 15 (1) A reduction or waiver of school impact fees owed by
- the seller or lessor for any project of the developer;

2		lessor pursuant to chapter 237, Hawaii Revised

4	(3)	A reduction or waiver of any tax owed pursuant to 247,

6		conveyance of the parcel or any subdivision of the
7		parcel;
8	(4)	An exemption from statutes, ordinances, charter
9		provisions, or rules pursuant to section 201H-38,
10		Hawaii Revised Statutes, for a housing development on
11		the parcel developed pursuant to chapter 201H, Hawaii
12		Revised Statutes; and
13	(5)	A loan guaranty of up to \$5,000,000 for a commercial
14		lender authorized to do business in the State for a
15		loan used to construct the affordable housing
16		contemplated in this Act;
17	provided	that the total value received by the seller or lessor
18	pursuant	to this subsection shall not exceed the value of the
19	property	in the event of a sale, the total value of the lease in
20	the event	of a lease, or the total value received by the State
21	in the ev	ent of another form of interest transfer.

9	SECTION 4. This Act shall not be construed to restrict or		
10	prohibit the Hawaii housing finance and development corporation

12	(1) Allocating any funds in the dwelling unit revolving		
13	fund established pursuant to section 201H-191, Hawaii		
14	Revised Statutes; or		
15	(2) Using any other loan or development program		
16	established pursuant to chapter 201H, Hawaii Revised		
17	Statutes,		
18	to facilitate the construction of any housing project at the		
19	real property identified as TMK (1) 9-1-102-027-0000.		
20	SECTION 5. This Act shall take effect on July 1, 2050;		
21	provided that section 3 shall take effect on July 1, 2022.
