

A BILL FOR AN ACT

RELATING TO THE LAW OF THE SPLINTERED PADDLE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that King Kamehameha I
- 2 enacted ke kānāwai māmalahoe, or the law of the splintered
- 3 paddle, to protect his people by proclaiming that all innocent
- 4 persons, especially the elderly and the youth, shall be allowed
- 5 to lay safely on the side of the road without fear of harm or
- 6 attack. This law was a symbol of the importance Native
- 7 Hawaiians placed on caring for others and ensuring the safety of
- 8 society's most vulnerable people and has endured for
- 9 generations.
- 10 The legislature further finds that the law of the
- 11 splintered paddle specifically states:
- "O my people
- 13 Honor thy gods
- Respect alike (the rights of)
- Men great and humble
- 16 See to it that our aged
- 17 Our women and our children

1 Lie down to sleep by the roadside 2 Without fear or harm. 3 Disobey, and die." 4 The legislature further finds that the law of the 5 splintered paddle is enshrined in article IX, section 10, of the 6 Hawaii State Constitution, which is both the supreme law of the 7 State of Hawaii and the document from which all other sources of 8 authority within the State are defined. The constitution 9 specifically declares that the law of the splintered paddle 10 "shall be a unique and living symbol of the State's concern for 11 public safety". The legislature believes that the State and 12 each of its political subdivisions must honor and uphold this 13 most important and eternal provision of its Constitution. 14 Accordingly, the purpose of this Act is to uphold the law 15 of the splintered paddle, as enshrined in the Hawaii State 16 Constitution, by prohibiting any county from disturbing any 17 person lying on the roadside of public lands in safety. 18 Chapter 46, Hawaii Revised Statutes, is amended SECTION 2. 19 by adding a new section to part V to be appropriately designated

and to read as follows:

7	(1)	This section shall not prohibit a duly empowered
8		county official from removing a person from a roadside
9		if conditions exist that would place the person at
10		risk of immediate bodily injury; and
11	(2)	Paragraph (1) shall not be construed to authorize any
12		official to engage in any unprovoked assault of,
13		threats to, or harassment of the person who is sitting
14		or lying down.
15	(d)	As used in this section, "by the roadside" includes
16	any sidewalk, as that term is defined in section 291C-1."	
17	SECTION 3. New statutory material is underscored.	
18	SECTION 4. This Act shall take effect upon its approval.
