1 Zoning in all counties shall be accomplished within the 2 framework of a long-range, comprehensive general plan prepared or being prepared to guide the overall future development of the 3 4 county. Zoning shall be one of the tools available to the county to put the general plan into effect in an orderly manner. 5 6 Zoning in the counties of Hawaii, Maui, and Kauai means the 7 establishment of districts of such number, shape, and area, and 8 the adoption of regulations for each district to carry out the 9 purposes of this section. In establishing or regulating the 10 districts, full consideration shall be given to all available 11 data as to soil classification and physical use capabilities of 12 the land to allow and encourage the most beneficial use of the 13 land consonant with good zoning practices. 

1 In arriving at an appropriate fine, the board may 2 consider the market value of the natural resource 3 damaged or taken and any other factor it deems 4 appropriate, such as the loss of the natural resource 5 to its natural habitat and environment and the cost of 6 restoration or replacement. The remedies provided for 7 in this paragraph are cumulative and in addition to 8 any other remedies allowed by law. 9 No person shall be sanctioned pursuant to this section 10 for the exercise of native Hawaiian gathering rights 11 and traditional cultural practices as authorized by 12 law or as permitted by the department pursuant to 13 article XII, section 7, of the Hawaii [state 14 constitution;] State Constitution; 15 (16) Issue revenue bonds, subject to the approval of the 16 legislature. All revenue bonds shall be issued 17 pursuant to part III of chapter 39, except as provided 18 in this chapter. All revenue bonds shall be issued in 19 the name of the department and not in the name of the 20 State. The final maturity date of the revenue bonds

Provides that the Board of Land and Natural Resources and Commission on Water Resource Management shall not conduct contested case hearings, and counties shall not conduct contested case hearings regarding disputes over land use, but that decisions and disputes may be contested and adjudicated in circuit court.
