A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
- 2 amended by adding a new section in part V to be appropriately
- 3 designated and to read as follows:
- 4 "§302A- Financial and management audits. The auditor
- 5 shall conduct an operational audit of the academic plans and the
- 6 financial plans of the department, assessing the efficiency and
- 7 effectiveness of the process from budget and planning, and
- 8 implementation to student outcomes annually. The auditor shall
- 9 submit a report of the auditor's findings, including any
- 10 proposed legislation, to the legislature no later than twenty
- 11 days prior to the convening of the regular session following the
- 12 audit."
- 13 SECTION 2. (a) The department of education shall contract
- 14 with a third-party consultant that specializes in school finance
- 15 to perform a study of the adequacy of education funding in
- 16 Hawaii. The third-party consultant shall have previous

4	(1)	Employ the evidence-based method to evaluate the
5		adequacy of school funding, but may include the
6		professional judgement method in its analysis;
7	(2)	Identify variables most closely associated with a
8		high-quality education and estimate the amount of
9		additional funding needed to provide all public school
10		students in Hawaii with an equal educational
11		opportunity;
12	(3)	Compare Hawaii teacher salaries with teacher salaries
13		in school districts of similar size and cost of living
14		to determine compensation characteristics that impact
15		the department of education's ability to recruit and
16		retain effective teachers; and
17	(4)	Assess the equity of funding between schools
18		throughout the Hawaii public school system.
19	(c)	The department of education shall submit to the
20	legislatu	re a copy of the study, along with a report of its
21	findings	and recommendations, including any proposed

- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2021-2022 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2022-2023 for the office of the auditor to conduct the
- 8 operational audits required by section 1 of this Act.
- 9 The sums appropriated shall be expended by the office of
- 10 the auditor for the purposes of this Act.
- 11 SECTION 4. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2021-2022 for
- 14 the department of education to contract with a third-party
- 15 consultant that specializes in school finance to perform a study
- 16 of the adequacy of education funding in Hawaii as required by
- 17 section 2 of this Act.
