BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 346, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "§346- Coverage of ambulance services. Beginning on
- 5 January 1, 2022, the State's medicaid programs:
- 6 (1) Shall provide coverage for ambulance services; and
- 7 (2) May also provide coverage for statewide community
- 8 paramedicine services rendered by emergency medical
- 9 technicians or paramedics."
- 10 SECTION 2. Chapter 431, Hawaii Revised Statutes, is

- 17 much thereof as may be necessary for fiscal year 2021-2022 and
- 18 the same sum or so much thereof as may be necessary for fiscal
- 19 year 2022-2023 for amounts necessary to comply with collectively

- 5 SECTION 8. In codifying the new sections added by sections
- 6 2 and 3 of this Act, the revisor of statutes shall substitute
- 7 appropriate section numbers for the letters used in designating
- 8 the new sections in this Act.
- 9 SECTION 9. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 10. This Act shall take effect on July 1, 2022.
