# HOUSE RESOLUTION

---

URGING THE HILO HIGH SCHOOL SCHOOL COMMUNITY COUNCIL TO  
RECOMMEND THAT THE HILO HIGH SCHOOL GYM BE NAMED AFTER  
ALBERT AND LAWRENCE MANLIGUIS.

1 WHEREAS, for over five decades, Albert and Lawrence  
2 Manliguais, also known fondly as Al and Larry Manliguais, have  
3 been synonymous with high school athletic and academic  
4 excellence, as well as achievement in basketball, particularly  
5 at Hilo High School where both brothers served as head coaches;  
6 and

8 WHEREAS, Albert and Lawrence Manliguais, together, coached  
9 forty-eight consecutive seasons at Hilo High School, where they  
10 led the Hilo High School Vikings to three state championships  
11 during that time; and  
12

13 WHEREAS, known for their incredible dedication, mentorship,  
14 and phenomenal coaching style that they passionately brought to  
15 their student-athletes, the Manliguais brothers led the Vikings  
16 to three stellar state basketball championships: two state  
17 championships were coached by Lawrence Manliguais and one state  
18 championship was coached by Albert Manliguais; and

20 WHEREAS, Albert and Lawrence Manliguais' fast-paced, up-  
21 tempo approach and full-court coaching style, along with the  
22 strong discipline, skills, and character they nurtured in their  
23 student-athletes led the Vikings to victory after victory; and

25 WHEREAS, besides guiding Hilo High School to state  
26 championships in 1991 and 2000, Lawrence Manliguais also led the  
27 team to a runner-up finish in 1992, and to eleven Big Island  
28 Interscholastic Federation titles; and

30 WHEREAS, in addition to his state championship in 1964,  
31 Albert Manliguais led the Vikings to nineteen Big Island  
32 Interscholastic Federation championships; and

2 WHEREAS, as the pride of Hilo High School and the Big  
3 Island community, it is only fitting to name Hilo High School  
4 Gym after Albert and Lawrence Manliguis for the honor and  
5 distinction they have brought to generations of Viking student-  
6 athletes and their families and for their noteworthy  
7 contributions and achievements to the sport of basketball at  
8 Hilo High School and in the State; now, therefore,

10 BE IT RESOLVED by the House of Representatives of the  
11 Thirty-first Legislature of the State of Hawaii, Regular Session  
12 of 2022, that the Hilo High School School Community Council is  
13 urged to recommend that Hilo High School Gym be named after  
14 Albert and Lawrence Manliguis for their longstanding commitment  
15 to athletic and academic excellence; and

17 BE IT FURTHER RESOLVED that a certified copy of this  
18 Resolution be transmitted to the Hilo High School School  
19 Community Council.
