A BILL FOR AN ACT

RELATING TO KOA TREES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that property owners who
- 2 demonstrate a knowledge of forestry, native ecosystems, and
- 3 responsible land stewardship practices deserve the right to
- 4 plant and harvest koa trees at their own discretion when their
- 5 property is public land leased from the department of land and
- 6 natural resources or the department of agriculture. The
- 7 legislature further finds that to ensure and protect these
- 8 rights regarding koa tree planting and harvesting, a specified
- 9 license to do so is the most effective way to ensure and protect
- 10 the rights of property owners and lessees to plant and harvest
- 11 koa trees.
- 12 Accordingly, the purpose of this Act is to authorize the
- 13 board of land and natural resources to issue licenses to
- 14 applicants desiring to plant, care for, and harvest koa trees in
- 15 certain circumstances.

1	SECTI	ON 2. Chapter 183, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated	
3	and to read as follows:	
4	" <u>§183</u>	- Licenses; koa tree planting and harvesting. (a)
5	The board	shall, as part of its management plan required under
6	section 18	3-16.5, identify all public lands that are suitable
7	for the planting and harvesting of koa trees.	
8	(b)	The administrator appointed by the board under section
9	183-3, shall be authorized to issue a license to an applicant	
10	desiring to plant, care for, and harvest koa trees on the	
11	applicant's leased public land if, upon application in the form	
12	prescribed by the department:	
13	(1)	The prospective lands upon which the koa trees are to
14		be planted have been determined suitable by the board
15		<pre>pursuant to subsection (a);</pre>
16	(2)	The applicant pays all appropriate fees; and
17	(3)	The applicant complies with all rules adopted by the
18		board pursuant to chapter 91 to carry out this
19		section.
20	<u>(c)</u>	Licenses issued under this section to lessees of lands
21	owned by t	the department or the department of agriculture shall

- 1 be entitled to plant, care for, and harvest koa trees at the
- 2 lessee's discretion."
- 3 SECTION 3. New statutory material is underscored.
- 4 SECTION 4. This Act shall take effect upon its approval.

Report Title:

Department of Land and Natural Resources; Division of Forestry and Wildlife; Koa Trees; License to Plant and Harvest

Description:

Requires the Board of Land and Natural Resources to identify all public lands suitable for the planting of koa trees. Authorizes the Administrator of Forestry and Wildlife to issue licenses to plant, care for, and harvest koa trees in certain circumstances. (SD1)
