BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 266-2, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows:

- "(a) The department of transportation shall:
- the duties which may lawfully be exercised by or under the State relative to the control and management of commercial harbors, commercial harbor and waterfront improvements, ports, docks, wharves, piers, quays, bulkheads, and landings belonging to or controlled by the State, and the shipping using the same;
- (2) Have the authority to use and permit and regulate the use of the commercial docks, wharves, piers, quays, bulkheads, and landings belonging to or controlled by the State for receiving or discharging passengers and for loading and landing merchandise, with a right to collect wharfage and demurrage thereon or therefor;

1	<u>(3)</u>	Have the authority to negotiate leases for the non-
2		maritime usage of commercial harbors, commercial
3		harbor and waterfront improvements, ports, docks,
4		wharves, piers, quays, bulkheads, and landings within
5		the designated boundaries of the Aloha Tower complex
