# A BILL FOR AN ACT

RELATING TO THE OCEAN STEWARDSHIP SPECIAL FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's ocean 2 waters and the marine resources contained within are some of the State's most ecologically, economically, and culturally valuable 3 4 environmental assets. The rising popularity of marine ecotourism combined with the growing threats of climate change 5 threaten the overall health of Hawaii's marine ecosystems. 6 7 Accordingly, to protect Hawaii's coastal waters, the legislature 8 passed Act 46, Session Laws of Hawaii 2021, to create the ocean 9 stewardship special fund for the conservation, restoration, and 10 enhancement of the State's marine resources.

11 The purpose of this Act is to authorize the ocean 12 stewardship special fund to expand its authorized usage to 13 include planning, development, designing, or implementation of 14 beach restoration projects, including grants to nonprofit 15 organizations for beach and nearshore environmental cleanup. 16 SECTION 2. Section 187A-51, Hawaii Revised Statutes, is 17 amended by amending subsection (c) to read as follows:

10		mitigation measures for impacts to the marine

12		environment from federal or state permitted actions,
13		or violations of subtitle 5 of title 12 or any rule
14		adopted thereunder; [ <del>and</del> ]
15	(3)	Install, maintain, and replace day use mooring buoys
16		and other infrastructure to reduce impacts to the
17		marine ecosystem[-]; and
18	(4)	Plan, design, develop, or implement beach restoration
19		projects, including the awarding of grants to
20		nonprofit organizations for beach and nearshore
21		environmental cleanup."
