# A BILL FOR AN ACT

---

RELATING TO DISASTER RELIEF.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$                   or so much  
3 thereof as may be necessary for fiscal year 2021-2022 to protect  
4 the health, safety, and welfare of the people and provide relief  
5 from disaster damages, losses, and suffering caused by  
6 extraordinary weather events that produced torrential rains and  
7 resultant flooding in the county of           , in           , 20   .  
8       The sum appropriated shall be allotted to the department of  
9 defense and expended by the adjutant general solely for the  
10 express stated purposes of this Act; provided that the moneys  
11 appropriated pursuant to this section shall not lapse at the end  
12 of the fiscal year for which the moneys have been appropriated;  
13 provided further that any moneys appropriated pursuant to this  
14 section that are unencumbered as of June 30,           , shall lapse  
15 on that date; provided further that the moneys appropriated  
16 pursuant to this section shall be exempt from section 37-74(d),  
17 Hawaii Revised Statutes.

19       SECTION 3. (a) Moneys appropriated pursuant to this Act  
20 shall be expended in accordance with section 127A-12(b), Hawaii

3 (b) The appropriations and expenditures made pursuant to  
4 this Act shall not be subject to the expenditure limitations  
5 established in section 127A-16, Hawaii Revised Statutes.

6 SECTION 4. This Act shall take effect upon its approval.
