### A BILL FOR AN ACT

RELATING TO DEPARTMENT OF EDUCATION RESIDENCY REQUIREMENTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that given expanding
telework options and infrastructure, the hiring of entirely
remote professionals for certain positions within the department
of education has the potential to satisfy critical hiring needs
in a fiscally prudent manner. This is particularly applicable
to positions in the areas of information technology and online
learning, as well as other highly specialized positions.

8 The purpose of this Act is to help satisfy critical hiring 9 needs in a fiscally prudent manner by exempting certain 10 department of education employees from the state residency 11 requirement under section 78-1, Hawaii Revised Statutes.

SECTION 2. Section 78-1, Hawaii Revised Statutes, isamended by amending subsection (f) to read as follows:

14 "(f) This section shall not apply to persons recruited and 15 <u>employed</u> by the University of Hawaii under the authority of 16 section [+] 304A-1001[].] and persons recruited and employed by
