A BILL FOR AN ACT

RELATING TO THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the Hawaii 2 interagency council on homelessness was established in 2012 to 3 provide solutions for ending homelessness in Hawaii. The membership of this council represents a wide cross section of 4 5 the community, including representatives from the government, 6 business community, faith-based community, and social services, 7 and was intended to provide the perspective and expertise 8 necessary to develop overall strategies to prevent and end 9 homelessness.

10 The legislature further finds that in the wake of the 11 coronavirus disease 2019 pandemic, the number of people 12 experiencing homelessness is expected to increase across the 13 State. According to True Colors United, an American nonprofit 14 organization that addresses youth homelessness in the United 15 States, forty per cent of homeless youth identify as LGBTQ+ and 16 LGBTQ+ youth are one hundred twenty per cent more likely to 17 experience homelessness than their non-LGBTQ+ peers.
