A BILL FOR AN ACT

RELATING TO DENTAL ASSISTANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to a 2016 2 report by the department of health, nearly one in four third 3 graders in Hawaii has untreated tooth decay, the highest rate in 4 the nation. More than sixty per cent of all children in Hawaii 5 lack protective dental sealants, which are a safe and costeffective intervention to prevent tooth decay in molar teeth. 6 7 The legislature further finds that this lack of access to 8 sufficient dental care has led to devastating health outcomes 9 among children, especially those in Native Hawaiian and Pacific 10 Islander communities. The high rate of tooth decay among 11 Hawaii's keiki can lead to significant pain that interferes with daily activities, such as eating, learning, and socializing. 12 13 Untreated cavities also increase the risk of more serious 14 infection in the mouth and body.
- The legislature also finds that the State lacks adequate
- 16 and accessible dental public health infrastructure, especially
- 17 on the neighbor islands. The 2015 Hawaii Oral Health Key

- 1 strategies to address the lack of adequate dental public health
- 2 infrastructure, including the development of community and
- 3 school-based dental disease prevention programs for all age
- 4 groups, continued support and expansion of affordable and
- 5 accessible preventive dental care services to the State's low-
- 6 income population, and further exploration of innovative,
- 7 evidence-based strategies to expand access to underserved, high-
- 8 risk populations.
- 9 The legislature additionally finds that dental assistants
- 10 could play an important role in improving access to dental
- 11 health care across the State. Although the Hawaii Dental
- 12 Practice Act allows dental hygienists to practice under the
- 13 general supervision of a dentist in public health settings,
- 14 dental assistants are prohibited from providing auxiliary
- 15 support except under direct supervision. This undermines the
- 16 efficacy of dental assistants in public health settings and
- 17 limits the reach and sustainability of community dental
- 18 programs.
- 19 The legislature further finds that, according to the Oral
- 20 Health Workforce Research Center, eight states, including
- 21 Alaska, Arizona, Maine, Maryland, Nebraska, New Mexico, Oregon,

- 1 and Wyoming, allow dental assistants to perform some tasks under
- 2 indirect or general supervision without licensure, registration,
- 3 or representation on the state board of dentistry. Allowing
- 4 dental assistants to provide limited, but essential, auxiliary
- 5 support under general supervision while in public health
- 6 settings would contribute to the development and sustainable
- 7 implementation of community-based dental disease prevention
- 8 programs. This would also expand providers' ability to offer
- 9 adequate and accessible oral health services to rural
- 10 communities and the State's most vulnerable residents.
- 11 The purpose of this Act is to allow dental assistants to
- 12 perform limited, essential duties under the general supervision
- 13 of a dentist in public health settings.
- 14 SECTION 2. Chapter 448, Hawaii Revised Statutes, is
- 15 amended by adding a new section to be appropriately designated
- 16 and to read as follows:
- 17 "§448- Supervision in public health settings. (a) A
- 18 dental assistant may operate under the general supervision of
- 19 any dentist licensed under this chapter to provide auxiliary
- 20 support dental services in a public health setting.

13	dental procedures:				
14	(1)	Taking intra-oral and extra-oral photographs, and			
15		recording or charting clinical findings as directed by			
16		the licensed dental hygienist;			
17	(2)	Exposing, processing, mounting, and labeling			
18		radiographs;			
19	(3)	Measuring and recording vital signs;			
20	(4)	Assisting the licensed dental hygienist who is			
21		performing a dental procedure on a patient, such as:
