A BILL FOR AN ACT

RELATING TO DETACHED DWELLINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended
2	by adding a new section to be appropriately designated and to
3	read as follows:
4	"§46- Detached dwellings; authorization required. (a)
5	Each county shall adopt ordinances authorizing the construction
6	and occupation of detached dwelling units upon application in
7	areas zoned as residential.
8	(b) Notwithstanding any other law to the contrary, a
9	county shall not deny issuance of a building permit for a
10	detached dwelling unit if:
11	(1) The property contains one single-family dwelling
12	occupied by the property owner, or family of the
13	property owner, unless the property owner will occupy
14	the detached dwelling unit after its completion;
15	(2) The floor area ratio of the property does not exceed
16	0.7, including the detached dwelling unit;

1	(3)	The number of bathrooms in the detached dwelling unit
2		does not exceed:
3		(A) Two on a zoning lot size up to six thousand nine
4		hundred ninety-nine square feet;
5		(B) Three on a zoning lot size between seven thousand
6		and nine thousand nine hundred ninety-nine square
7		feet; or
8		(C) Four on a zoning lot size of ten thousand square
9		feet or greater;
10	(4)	The detached dwelling unit is furnished with a kitchen
11		sink, cooking appliance, and refrigeration facilities,
12		each having a clear working space of no less than
13		thirty inches in front;
14	(5)	The impervious surface area of the zoning lot does not
15		exceed seventy-five per cent of the total zoning lot
16		area, including the detached dwelling unit;
17	(6)	The number of wet bars in the detached dwelling unit
18		does not exceed one; and
19	(7)	The detached dwelling unit has a floor area of:
20		(A) At least two hundred twenty square feet:

1	<u>(B)</u>	No more than eight hundred fifty square feet if
2		the unit contains one bedroom; or
3	<u>(C)</u>	No more than one thousand square feet if the unit
4		contains more than one bedroom;
5	provided that	the detached dwelling unit otherwise meets
6	residential per	rmitting requirements."
7	SECTION 2	. New statutory material is underscored.
8	SECTION 3	. This Act shall take effect upon its approval.

Description:

Requires each county to adopt ordinances authorizing detached dwelling units that meet certain minimum standards. Prohibits a county from denying a building permit under certain conditions.
