A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness in
- 2 Hawaii is a long-term problem. The legislature acknowledges
- 3 that homelessness requires greater collaboration and
- 4 coordination among diverse government entities, businesses,
- 5 nonprofit organizations, and faith-based organizations.
- 6 Accordingly, the legislature enacted Act 105, Session Laws of
- 7 Hawaii 2012. Act 105, in part, formally established the Hawaii
- 8 interagency council on homelessness, which was temporarily
- created through Executive Order No. 11-21, and allowed the 9
- 10 council to continue identifying critical strategic goals and
- initiatives that would mitigate homelessness while ensuring that 11
- persons experiencing homelessness obtain permanent housing and 12
- 13 become reintegrated into the community. As one of its statutory
- 14 duties, the council adopted a ten-year plan on September 10,
- 2012. At that time, the point-in-time count or the annual one-15
- day unduplicated count of sheltered and unsheltered individuals 16
- 17 and families experiencing homelessness in the State totaled



- 1 7,921 statewide. Eight years later, in 2020, the point-in-time
- 2 count totaled 6,458.
- 3 While the Hawaii interagency council on homelessness has a
- 4 ten-year plan, the legislature further finds that the State
- 5 lacks a long-term commitment to reduce, prevent, and end
- 6 homelessness. Various state agencies and programs that address
- 7 homelessness have been built up on a piecemeal basis and have
- 8 approached homelessness in a similar manner. There is no
- 9 central agency tasked with finding solutions to homelessness
- 10 through reduction and prevention by coordinating state and local
- 11 government agencies and private entities.
- 12 The legislature recognizes that year-to-year funding,
- 13 rather than consistent funding in the base budget, creates
- 14 uncertainty for the staff of a program to continue fulfilling
- 15 the staff's duties and responsibilities. For example, in 2019,
- 16 the legislature enacted Act 81, Session Laws of Hawaii 2019,
- 17 which appointed the governor's coordinator on homelessness to
- 18 administer and enforce the duties and responsibilities of the
- 19 council. The coordinator is currently funded as a special
- 20 project under the department of human services, while the
- 21 coordinator's full-time staff of four are not permanent

- 1 employees. In addition, year-to-year funding among agencies and
- 2 providers for homeless services threatens already potentially
- 3 sporadic and fragmented services, instead of providing
- 4 consistent support that will help permanently house persons
- 5 experiencing homelessness in the State.
- 6 Accordingly, the purpose of this Act is to:
- 7 (1) Establish the office on homelessness and housing
- 8 solutions; and
- 9 (2) Make an appropriation.
- 10 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 11 amended by adding a new part to be appropriately designated and
- 12 to read as follows:
- 13 "PART . OFFICE ON HOMELESSNESS AND HOUSING SOLUTIONS
- 14 § -1 Definitions. As used in this part, unless the
- 15 context clearly indicates otherwise:
- 16 "Coordinator" means the governor's coordinator on
- 17 homelessness as provided in section 346-381.5.
- 18 "Fund" means the homelessness and housing solutions special
- 19 fund.
- 20 "Office" means the office on homelessness and housing
- 21 solutions.

1	§ -2 Office on homelessness and housing solutions;
2	establishment. There is established within the department of
3	human services, for administrative purposes only, an office on
4	homelessness and housing solutions that shall:
5	(1) Work with state, county, and community agencies to
6	develop solutions to prevent and end homelessness in
7	the State through transitional and permanent housing
8	and supportive or assisted services, or both; and
9	(2) Test innovative solutions to prevent and end
10	homelessness in the State.
11	§ -3 Administration. (a) The office on homelessness
12	and housing solutions shall be headed by the governor's
13	coordinator on homelessness, appointed under section 346-381.5,
14	for the proper administration and enforcement of this part.
15	(b) The coordinator shall report directly to the governor
16	and appoint staff as may be necessary.
17	(c) The employees of the office shall be exempt from
18	chapter 76.

19	fund; provided that any moneys appropriated pursuant to this			
20	section shall be in addition to, and shall not supplant, any			
21	portion of the budget used for ohana zones pilot program or			

- 1 housing first program funding, the rental housing revolving
- 2 fund, and any other existing fund.
- 3 SECTION 4. There is appropriated out of the homelessness
- 4 and housing solutions special fund the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2022-2023 for
- 6 the administration of the office of homelessness and housing
- 7 solutions; provided that each county shall provide support for
- 8 programs within the respective county and the governor's
- 9 coordinator on homelessness shall seek matching funds from the
- 10 county in which any proposed capital improvements are built or
- 11 created.
- 12 The sum appropriated shall be expended by the department of
- 13 human services for the purposes of this Act.
- 14 SECTION 5. This Act shall take effect on July 1, 2050.
