A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the corrections
- 2 division of the department of public safety oversees eight
- 3 correctional facilities in the State: the Halawa correctional
- 4 facility, Hawaii community correctional center, Kauai community
- 5 correctional center, Kulani correctional facility, Maui
- 6 community correctional center, Oahu community correctional
- 7 center, Waiawa correctional facility, and women's community
- 8 correctional center.
- 9 The legislature recognizes that correctional facilities
- 10 throughout the State face issues of overcrowding and
- 11 understaffing, creating threats to the safety and well-being of
- 12 the adult corrections officers working in these correctional
- 13 facilities. The legislature notes that adult corrections
- 14 officers have been the subject of numerous attacks by inmates in
- 15 the State's correctional facilities. In 2017, three adult
- 16 corrections officers were attacked by inmates at the Oahu
- 17 community correctional center. In 2018, an adult corrections



- 1 officer received head and facial injuries after being attacked
- 2 by an inmate at the Maui community correctional center. In
- 3 2020, two adult corrections officers were allegedly attacked by
- 4 inmates at the Hawaii community correctional center over a
- 5 social distancing dispute. In 2021, an adult corrections office
- 6 was assaulted by a Maui community correctional center inmate.
- 7 The legislature further finds that, despite these incidents, the
- 8 most recent studies and reviews of the security staffing needs
- 9 of each correctional facility were in 1992 and 1996 pursuant to
- 10 Act 300, Session Laws of Hawaii 1992, and Act 287 Session Laws
- 11 of Hawaii 1996, respectively. Further, while the office of the
- 12 auditor collected data on correctional facility staffing in 2015
- 13 for the purpose of an audit, the office did not complete the
- 14 audit due to a change in office leadership.
- 15 Accordingly, the purpose of this Act is to require the
- 16 auditor to conduct a management audit of the corrections
- 17 division of the department of public safety.
- 18 SECTION 2. (a) The auditor shall conduct a management
- 19 audit of the corrections division of the department of public
- 20 safety to:
- 21 (1) Evaluate the corrections division's:



1		(A)	Recruitment and retention rates; and
2		(B)	Hiring policies and practices;
3	(2)	Dete	ermine whether:
4		(A)	The State's correctional facilities are
5			sufficiently staffed;
6		(B)	Any staffing issues at the State's correctional
7			facilities may be adequately addressed by the
8			hiring of individuals on an emergency basis;
9		(C)	The State's correctional facilities comply with
10			the Family and Medical Leave Act of 1993 and
11			national best practices regarding safety
12			regulations for on-duty adult corrections
13			officers, including whether adult corrections
14			officers are equipped with sufficient safety
15			devices and provided with appropriate training;
16		(D)	The corrections division's recruitment and
17			retention policies meet national best practices;
18		(E)	The managers of the State's correctional
19			facilities consider the reasons for adult
20			corrections officers' departures; and

1	(F)	The department of public safety has enacted any
2		process to curtail abuse by adult corrections
3		officers of temporary disability insurance and
4		workers compensation benefits.

(3) Review:

- (A) The department of public safety's policies and practices of staffing essential and non-essential posts, including any negotiated policies and practices, and whether these classifications provide the highest level of safety for the inmates and adult corrections officers;
- (B) The compliance and usage of negotiated vacation leave, sick leave, shortage pay, and temporary hazard pay and whether the usage rates are consistent with other correctional facilities in other divisions within the State;
- (C) Adult corrections officer scheduling and post assignments and whether the scheduling and post assignments follow the department of public safety's policies and procedures and meet national best practices; and

1	(D) The department of public safety's practice of
2	temporarily assigning Oahu community correctional
3	facility adult corrections officers to the Halawa
4	correctional facility and determine the impact of
5	this practice on Oahu community correctional
6	facility's staffing issues; and
7	(4) Analyze any other topics that the auditor deems
8	appropriate.
9	(b) The auditor shall submit a report of its findings and
10	recommendations, including any proposed legislation, to the
11	legislature no later than twenty days prior to the convening of
12	the regular session of 2023.
13	SECTION 3. There is appropriated out of the general
14	revenues of the State of Hawaii the sum of \$ or so
15	much thereof as may be necessary for fiscal year 2022-2023 for
16	the auditor to conduct a management audit of the corrections
17	division of the department of public safety.
18	The sum appropriated shall be expended by the auditor for
19	the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2022.
