A BILL FOR AN ACT

RELATING TO ECONOMIC DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to transfer the
- 2 administrative attachment of the agribusiness development
- 3 corporation from the department of agriculture to the department
- 4 of business, economic development, and tourism.
- 5 SECTION 2. Section 163D-1, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "[f] §163D-1[f] Findings and purpose. The legislature
- 8 finds that the downsizing of the sugar and pineapple industries
- 9 [is presenting] presented an unprecedented opportunity for the
- 10 conversion of agriculture into a dynamic growth industry.
- 11 Within the next decade, [seventy five thousand] the State can
- 12 use public agricultural lands to enhance the local economy,
- 13 provide employment opportunities, decrease reliance on imported
- 14 agricultural products, and provide more sources of locally grown
- 15 food for residents. Thousands of acres of agricultural lands
- 16 and fifty million gallons per day of irrigation water [are
- 17 expected to be] were released by plantations. The downsizing of



- 1 the sugar and pineapple industries [will idle] idled and left
- 2 vacant a valuable inventory of supporting infrastructure
- 3 including irrigation systems, roads, drainage systems,
- 4 processing facilities, workshops, and warehouses[-] that are
- 5 still largely underutilized. The challenge to government and
- 6 business is to continue to conserve and convert the arable lands
- 7 and their associated production infrastructure in a timely
- 8 manner into new productive uses [that are based upon strategies
- 9 developed from detailed marketing analysis and monitoring of
- 10 local, national, and international opportunities. Constantly
- 11 evolving economies require an aggressive]. Aggressive and
- 12 dynamic leadership [for the promotion] can play a critically
- 13 important role in promoting and development of agricultural
- 14 enterprises, [and centralized leadership to coordinate]
- 15 coordinating industry development, provide industry-wide
- 16 services, [provide] providing marketing assistance, and
- 17 [facilitate] facilitating investments and coventures in viable
- 18 enterprises.
- 19 The purpose of this chapter is to create a vehicle and
- 20 process to make optimal use of agricultural assets for the
- 21 economic, environmental, and social benefit of the people of

- 1 Hawaii. This chapter establishes a public corporation to
- 2 administer an aggressive and dynamic agribusiness development
- 3 program. The purposes of the corporation shall be to support
- 4 the production of local agricultural products for local
- 5 consumption in a manner that is economically and environmentally
- 6 sustainable while continuing to develop commercial exports of
- 7 locally produced agriculture products. To further these
- 8 purposes, the corporation shall coordinate and administer
- 9 programs to assist agricultural enterprises to facilitate the
- 10 transition of agricultural infrastructure from plantation
- 11 operations into other agricultural enterprises, [to carry on the
- 12 marketing analysis to direct agricultural industry evolution,
- 13 and to provide the leadership for the development, financing,
- 14 improvement, or enhancement of agricultural enterprises.
- 15 increase local production of agricultural products for local
- 16 consumption, reduce the State's reliance on imported
- 17 agricultural products, and increase access to farmland and
- 18 related infrastructure for small local farmers and
- 19 cooperatives."

- 1 SECTION 3. Section 163D-2, Hawaii Revised Statutes, is
- 2 amended by amending the definition of "agriculture" to read as
- 3 follows:
- 4 ""Agriculture" means the production for [marketing]
- 5 consumption within the State and exporting of plant and animal
- 6 life on land and within ponds and other bodies of water for
- 7 food, fiber, and raw materials for value-added products, and any
- 8 agricultural enterprise or enterprises organized for the
- 9 production of agricultural materials or value-added products
- 10 based on detailed marketing analysis and strategies to exploit
- 11 profitable potentials in local, national, and international
- 12 markets, including general farming, cane growing, fruit growing,
- 13 flower growing, aquaculture, growing of timber and forest
- 14 products, apiary, grazing, dairying, and the production of any
- 15 form of livestock or poultry, and their appurtenant services and
- 16 facilities."
- 17 SECTION 4. Section 163D-3, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "§163D-3 Agribusiness development corporation; board of
- 20 directors; established. (a) There is established the
- 21 agribusiness development corporation, which shall be a public

- 1 body corporate and politic and an instrumentality and agency of
- 2 the State. The corporation shall be headed by a board of
- 3 directors. The corporation shall be placed within the
- 4 department of [agriculture] business, economic development, and
- 5 tourism for administrative purposes, but the corporation may
- 6 later incorporate as a nonprofit corporation if this proves
- 7 desirable to further its objectives; provided that [such]
- 8 reorganization as a nonprofit corporation shall not adversely
- 9 affect the federal tax status of the interest on any bonds
- 10 issued to finance any project or project facility.
- 11 (b) The board of directors of the corporation shall
- 12 consist of eleven voting members, of whom eight shall be
- 13 appointed by the governor. The terms of these eight members
- 14 shall be four years; provided that, commencing on July 1, 2005,
- 15 the governor shall reduce the terms of those initially appointed
- 16 so as to provide, as nearly as can be, for the expiration of an
- 17 equal number of terms at intervals of one year. The eight
- 18 members shall be selected on the basis of their knowledge,
- 19 experience, and proven expertise in small and large businesses
- 20 within the agricultural industry, agricultural economics,
- 21 banking, real estate, finance, promotion, marketing, local food

- 1 production, and management. Of these eight members, one shall
- 2 be from the city and county of Honolulu, one shall be from the
- 3 county of Hawaii, one shall be from the county of Maui, one
- 4 shall be from the county of Kauai, and four shall be appointed
- 5 at-large. The director of business, economic development, and
- 6 tourism; the chairperson of the board of agriculture; and the
- 7 chairperson of the board of land and natural resources, or their
- 8 designated representatives, shall be ex-officio, voting members
- 9 of the board. All members shall continue in office until their
- 10 respective successors have been appointed and qualified. The
- 11 board shall annually elect its chairperson from among its
- 12 members; provided that the chairperson shall not be an ex-
- 13 officio member.
- 14 (c) The members of the board shall serve without
- 15 compensation, but shall be reimbursed for actual expenses
- 16 incurred in the performance of their duties.
- 17 (d) The board shall appoint an executive director, who
- 18 shall serve at the pleasure of the board and shall be exempt
- 19 from chapter 76. The salary of the executive director shall be
- 20 set by the board.

1 The board shall develop and document annual goals and (e) 2 performance measures for the executive director that allow the 3 board to annually evaluate the executive director's work to 4 ensure compliance by the corporation with statutory requirements 5 and achievement of its statutory purposes. 6 (f) The board shall evaluate and document the evaluation 7 of the executive director's performance annually, or more 8 frequently upon the request of at least four board members, 9 based on annual goals, performance measures, and other relevant 10 criteria. 11 (g) The board shall document the specific authority 12 delegated to the executive director, including but not limited 13 to the types of access and use of corporation property that the 14 executive director can approve without notice to or approval by the board, and the rent credits and other amendments to board-15 16 approved contract terms that the executive director may approve 17 without notice to or approval by the board. 18 [+(e)+] (h) The board, through its executive director, may 19 appoint officers, agents, and employees; prescribe their duties 20 and qualifications; and fix their salaries, without regard to

- 3 SECTION 8. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$100,000 or so much
- 5 thereof as may be necessary for fiscal year 2022-2023 for a
- 6 consultant to assist the agribusiness development corporation in
- 7 preparing and finalizing the Hawaii agribusiness plan under
- 8 section 163D-5, Hawaii Revised Statutes, including the
- 9 facilitation of community stakeholder involvement.
- 10 The sum appropriated shall be expended by the agribusiness
- 11 development corporation for the purposes of this Act.
- 12 SECTION 9. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2022-2023 for
- 15 one full-time equivalent (1.0 FTE) permanent accountant position
- 16 to provide accounting and other fiscal support services to the
- 17 agribusiness development corporation.
- 18 The sum appropriated shall be expended by the agribusiness
- 19 development corporation for the purposes of this Act.
- 20 SECTION 10. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$500,000 or so much

- 1 thereof as may be necessary for fiscal year 2022-2023 for
- 2 security guard services to address trespassing, abandonment of
- 3 vehicles on agribusiness development corporation land, and other
- 4 security issues on vacant land of the agribusiness development
- 5 corporation; provided that once agribusiness development
- 6 corporation land is leased, security costs for the property
- 7 shall be funded by agricultural cooperative association dues of
- 8 property tenants.
- 9 The sum appropriated shall be expended by the agribusiness
- 10 development corporation for the purposes of this Act.
- 11 SECTION 11. All rights, powers, functions, and duties of
- 12 the department of agriculture relating to the agribusiness
- 13 development corporation are transferred to the department of
- 14 business, economic development, and tourism.
- 15 SECTION 12. All appropriations, records, equipment,
- 16 machines, files, supplies, contracts, books, papers, documents,
- 17 maps, and other personal property heretofore made, used,
- 18 acquired, or held by the department of agriculture relating to
- 19 the functions transferred to the department of business,
- 20 economic development, and tourism shall be transferred with the

1 SECTION 13. All employees who occupy civil service 2 positions and whose functions are transferred to the department of business, economic development, and tourism by this Act shall 3 retain their civil service status, whether permanent or 4 5 temporary. Employees shall be transferred without loss of 6 salary, seniority (except as prescribed by applicable collective 7 bargaining agreements), retention points, prior service credit, 8 any vacation and sick leave credits previously earned, and other 9 rights, benefits, and privileges, in accordance with state 10 personnel laws and this Act; provided that the employees possess 11 the minimum qualifications and public employment requirements 12 for the class or position to which transferred or appointed, as 13 applicable; provided further that subsequent changes in status 14 may be made pursuant to applicable civil service and 15 compensation laws. 16 Any employee who, prior to this Act, is exempt from civil 17 service and is transferred as a consequence of this Act may 18 retain the employee's exempt status, but shall not be appointed 19 to a civil service position as a consequence of this Act. An 20 exempt employee who is transferred by this Act shall not suffer

any loss of prior service credit, vacation or sick leave credits

- 1 previously earned, or other employee benefits or privileges as a
- 2 consequence of this Act; provided that the employees possess
- 3 legal and public employment requirements for the position to
- 4 which transferred or appointed, as applicable; provided further
- 5 that subsequent changes in status may be made pursuant to
- 6 applicable employment and compensation laws. The director of
- 7 business, economic development, and tourism may prescribe the
- 8 duties and qualifications of these employees and fix their
- 9 salaries without regard to chapter 76, Hawaii Revised Statutes.
- 10 SECTION 14. All rules, policies, procedures, guidelines,
- 11 and other material adopted or developed by the department of
- 12 agriculture to implement provisions of the Hawaii Revised
- 13 Statutes that are reenacted or made applicable to the department
- 14 of business, economic development, and tourism by this Act shall
- 15 remain in full force and effect until amended or repealed by the
- 16 department of business, economic development, and tourism
- 17 pursuant to chapter 91, Hawaii Revised Statutes. In the
- 18 interim, every reference to the department of agriculture, board
- 19 of agriculture, or chairperson of the board of agriculture in
- 20 those rules, policies, procedures, guidelines, and other
- 21 material is amended to refer to the department of business,

- 1 economic development, and tourism or director of business,
- 2 economic development, and tourism, as appropriate.
- 3 SECTION 15. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 16. This Act shall take effect on July 1, 2050.
