A BILL FOR AN ACT

RELATING TO PROSTITUTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 712-1209.6, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§712-1209.6 Prostitution; motion to vacate conviction.
- 4 (1) A person convicted of or who has a nolo contendere plea
- 5 accepted by the court under section 853-2 for committing the
- 6 offense of prostitution under section 712-1200, loitering for
- 7 the purpose of engaging in or advancing prostitution under
- 8 section 712-1206(2), street prostitution and commercial sexual
- 9 exploitation in designated areas under section 712-1207(1)(a) or
- 10 (2)(a), or convicted of or has a nolo contendere plea accepted
- 11 by the court under section 853-2 for a lesser offense when
- 12 originally charged with a violation of section 712-1200,
- 13 712-1206(2), or 712-1207(1)(a) or (2)(a), may file a motion to
- 14 vacate the conviction if the defendant is not subsequently
- 15 convicted of any offense under the Hawaii Penal Code within
- 16 three years after the date of the original conviction[-] or
- 17 deferral of the nolo contendere plea under section 853-1;



- 1 provided that the nolo contendere plea is ultimately accepted by
- 2 the court under section 853-2. A person's right to file a
- 3 motion to vacate a conviction under this section shall be
- 4 applied retroactively.
- 5 (2) The court shall hold a hearing on a motion filed under
- 6 this section to review the defendant's record over the three
- 7 years after the date of the deferral of the nolo contendere plea
- 8 under section 853-1 or the original conviction under section
- 9 712-1200, 712-1206(2), or 712-1207(1)(a) or (2)(a) or conviction
- 10 or acceptance of a nolo contendere plea under section 853-2 of a
- 11 lesser offense when originally charged with a violation of any
- 12 of those sections, and if the court finds that the defendant has
- 13 not been convicted of any offense under the Hawaii Penal Code
- 14 within this three year period, the court shall vacate the
- 15 conviction."
- 16 SECTION 2. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 3. This Act shall take effect upon its approval.

Report Title:

Prostitution; Vacate; Conviction; Deferred Acceptance of Nolo Contendere Plea; Retroactive

Description:

Allows defendants who enter deferred acceptance of nolo contendere pleas to have the conviction vacated if conditions are met. Amends the statute to specify that the three-year period begins after the original deferral of the nolo contendere plea.
