### A BILL FOR AN ACT

RELATING TO LAND USED BY THE UNITED STATES MILITARY IN HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many properties in
- 2 the State are under claim of federal ownership or control and
- are being, or have been, used as military facilities. 3
- 4 military's deficient stewardship has resulted in contamination
- to both fresh and ocean waters and soil on and adjacent to many 5
- 6 of these properties, and on occasion has created hazards, such
- 7 as from the presence of unexploded ordnance.
- The upcoming expiration or renewal of land leases between 8
- 9 the State and the United States government and the potential
- return to the State of ceded lands all require a proactive 10
- 11 approach by the State.
- Accordingly, the purpose of this Act is to create a long-12
- 13 term task force to proactively plan for the remediation and
- 14 restoration of, and alternative uses for, lands currently under
- federal control that are anticipated to be returned to State 15
- control, as well as lands that are allowed to continue under 16
- federal control. 17



1	SECT	ION 2. (a) There is established a surplus military
2	land task	force within the office of planning and sustainable
3	developme	nt for administrative purposes to consist of the
4	following	members or their designees:
5	(1)	The director of the office of planning and sustainable
6		development, who shall serve as the chair of the task
7		force;
8	(2)	One member designated by the speaker of the house of
9		representatives;
10	(3)	One member designated by the president of the senate;
11	(4)	The chairs of the house and senate standing committees
12		with subject matter jurisdiction encompassing
13		environmental protection and restoration;
14	(5)	A representative from each of the four counties, to be
15		selected by the mayor of each county;
16	(6)	A representative from an organization whose mission
17		statement or purpose is dedicated to the remediation
18		and prevention of military debris and site
19		contamination or degradation; and
20	(7)	A representative from an organization with a mission
21		statement or purpose of preserving Native Hawaiian

1	cradicional and cultural practices and preventing the
2	desecration of the environment to be selected
3	by .
4	(b) The task force shall proactively plan for the
5	remediation and restoration of, and alternative uses for, lands
6	currently under federal ownership and control that are
7	anticipated to be returned to the State, as well as those lands
8	that are anticipated to continue under federal control. To
9	accomplish this objective, the task force shall:
10	(1) Create and maintain an inventory of all lands within
11	the State where the federal government claims
12	ownership or control, including a database of relevant
13	leases and their expiration dates and plans for
14	closure of military facilities on those lands,
15	building on but not necessarily limited to the
16	information contained in the latest edition of the
17	Hawaii Military Land Use Master Plan, and in the
18	report prepared by the office of planning and
19	sustainable development in response to Act 93, Session
20	Laws of Hawaii 2021;

1	(2)	Identify any known contaminants or environmental
2		hazards associated with inventoried lands, any
3		environmental studies performed in connection with
4		those lands, and any required remediation;
5	(3)	Seek input from adjacent communities, appropriate
6		departments and agencies, and the office of Hawaiian
7		affairs, on proposed environmental remediation and
8		alternative uses for the lands;
9	(4)	Identify lands appropriate to be set-aside by the
10		federal government;
11	(5)	Suggest alternative models for continued occupation
12		and remediation of lands that may be occupied by the
13		United States in the future, including compensation
14		for prior occupation and damages to such properties;
15	(6)	Negotiate with the appropriate federal agencies for
16		the return of ownership and control and environmental
17		remediation and restoration of parcels still under the
18		ownership or control of the federal government,
19		whether subject to return or not, and a timeline for
20		these actions; and

1	(7)	Work on any other objectives deemed necessary by the	
2		task force.	
3	(c)	The task force shall:	
4	(1)	Submit a preliminary report of its findings and	
5		recommendations, including any proposed legislation,	
6		to the legislature no later than twenty days prior to	
7		the convening of the regular session of 2023; and	
8	(2)	Submit a second report on its findings and	
9		recommendations, including any proposed legislation,	
10		to the legislature no later than twenty days prior to	
11		the convening of the regular session of 2024.	
12	The reports shall include status updates on each of the tasks		
13	specified	in subsection (b).	
14	(d)	The director of planning and sustainable development	
15	shall submit annual progress reports to the legislature no late		
16	than twenty days prior to the convenings of the regular session		
17	of 2025,	2026, 2027, 2028, and 2029. The progress reports shall	
18	include updates regarding the implementation of the work		
19	identified by the task force and any additional plans,		
20	recommend	ations, or proposed legislation recommended based on	

new information received by the office of planning and

- 1 sustainable development relating to the objectives of the task
- 2 force.
- 3 SECTION 3. This Act shall take effect upon its approval.
