### A BILL FOR AN ACT

RELATING TO AMBULANCE SERVICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the Makalei fire
station was established in 2013 to serve the fast-growing
population in north Kona on Hawai'i island. The steep increase
in population has corresponded with a steady increase in calls
for emergency medical services, which existing first responders
have been able to respond to in eight to thirty minutes,
depending on availability.

The legislature further finds that for residents of 8 9 Makalei, the closest primary care services and facilities are 10 thirty miles away. In addition to economic and transportation 11 challenges, emergency medical services have become the main 12 delivery method and access to health care for residents in 13 rural, isolated communities. Due to the lack of resources, it 14 is a common practice for paramedics to respond to ten or more 15 calls for emergency medical transportation during a twenty-four-16 hour shift. A timely response to a 911 call is critical to

reduce death and disability among residents and visitors on
Hawai'i island.

The legislature further finds that in recent years, 3 4 legislative efforts such as Senate Bill No. 877 (2020) have 5 requested funding to establish a life support ambulance in 6 Makalei. However, past efforts have stalled due to concerns 7 over an insufficient appropriation request and lack of staffing. 8 The legislature finds that more information is necessary to 9 determine the need and approximate cost to purchase one advanced 10 life support ambulance to be based in Makalei, as well as 11 related personnel costs for state-certified emergency medical 12 services personnel.

Accordingly, the purpose of this Act is to require the department of health and county of Hawai'i to conduct a feasibility study for the implementation of an ambulance service for the town of Makalei, county of Hawai'i.

SECTION 2. The department of health and the county of Hawaii shall conduct a feasibility study for the implementation of an ambulance service for the town of Makalei in the county of Hawaii. The feasibility shall include a recommendation to most efficiently provide ambulance service for the town of Makalei.
