A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State's future 2 depends on further development of the agricultural sector for its security, economic development, and sustainability. In the 3 most recent Comprehensive Economic Development Strategy plans, 4 the State and all four counties identified agriculture as 5 6 targeted industry clusters for regional economic development. A qualified workforce to support agriculture, food innovation, 7 8 natural resources, and related employment is necessary to 9 advance the State's goals.

10 The Legislature further finds that career pathways map out 11 the education, training, and experiences necessary to prepare 12 young people for employment and career success. When career 13 pathways are well-executed, young people are prepared to meet 14 the needs of the State's high-skill, high-wage, in-demand, and 15 future-focused workforce.

16 The legislature additionally finds that there is a critical 17 need for an implementation plan for career pathways for the

1 agricultural sector that prepares more of the State's young 2 people to be Hawaii's future agricultural workforce, which 3 includes scientists, inspectors, food producers, field 4 technicians, natural resource managers, entrepreneurs, and of 5 course, farmers.

6 The purpose of this Act is to establish a working group to 7 study and develop an implementation plan for career pathways in 8 the agricultural sector.

9 SECTION 2. (a) There is established a working group to 10 study and prepare an implementation plan for agricultural career 11 pathways. The working group shall be attached to the department 12 of education for administrative and fiscal purposes. The 13 working group shall be composed of members selected by the 14 department of education in consultation with the University of 15 Hawaii.

(b) The working group shall study and prepare an
implementation plan for career pathways from high school to
postsecondary education and training that prepares young people
for employment in the agricultural sector and to meet present
and future workforce needs. In preparing the implementation
plan for career pathways, the working group shall consider:

1 indicate the opportunities to advance in the career 2 pathway toward a living wage. 3 (c) The working group shall submit to the legislature an 4 analysis of agricultural workforce needs no later than twenty 5 days prior to the convening of the regular session of 2023. 6 (d) The working group shall submit to the legislature an 7 implementation plan, including recommendations and any proposed legislation, for career pathways from high school to 8 9 postsecondary education and training for in-demand or projected needs for the agricultural sector in Hawaii no later than twenty 10 11 days prior to the convening of the regular session of 2024. The working group shall dissolve on June 1, 2024. 12 (e) SECTION 3. There is appropriated out of the general 13 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2022-2023 for the establishment and operation of the working group established 16 under section 2 of this Act. 17

18 The sum appropriated shall be expended by the department of 19 education for the purposes of this Act.
