A BILL FOR AN ACT

RELATING TO AGRICULTURAL INSPECTION FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 150A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 Inspection fee; invasive species and diseases.
- 5 There is imposed a fee for the inspection, quarantine,
- 6 and eradication of invasive species, pests, or bacteria
- 7 contained in freight, including marine commercial container
- 8 shipment, air freight, or any other means of transporting
- 9 freight, foreign or domestic, but not including aggregate bulk
- 10 freight, cement bulk freight, coal bulk freight, or liquid bulk
- 11 freight, that is brought into the State.
- 12 The required inspection, quarantine, or eradication (b)
- 13 and the fee therefor shall be imposed on freight of agriculture
- 14 product types that are currently grown or produced in the State,
- 15 including commercial green and roasted coffee for blending.
- 16 (c) The transportation company shall bill the fee to the
- 17 person responsible for paying the freight charges to the



- 1 transportation company within fifteen days of the delivery of
- 2 the freight. The fee shall be paid by the person responsible
- 3 for paying the freight charges to the transportation company
- 4 within forty-five days of receipt of the bill. The
- 5 transportation company shall collect the fee from the person
- 6 responsible and forward the payment to the department at the
- 7 port of disembarkation within forty-five days of receipt of the
- 8 fee; provided that the transportation company shall not be
- 9 liable for any fee that is not paid by the person responsible
- 10 for paying the freight charges to the transportation company.
- 11 (d) The fee shall be assessed and collected on the net
- 12 weight of the imported freight computed on the basis of 5 cents
- 13 for every one pound of freight, or part thereof, brought into
- 14 the State.
- 15 (e) All fees collected under this section shall be
- 16 deposited into a special fund established by the department and
- 17 expended to support agricultural production in the State."
- 18 SECTION 2. New statutory material is underscored.
- 19 SECTION 3. This Act shall take effect upon its approval.
