A BILL FOR AN ACT

RELATING TO THEFT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 708, Hawaii Revised Statutes, is
2	amended by adding a new section to part IV to be appropriately
3	designated and to read as follows:
4	"§708- Theft of catalytic converter. (1) A person
5	commits the offense of theft of catalytic converter if the
6	person:
7	(a) Obtains a catalytic converter through any means
8	described in section 708-830; or
9	(b) Violates section 445-233 in regard to a catalytic
10	converter.
11	(2) For the purposes of this section, "catalytic
12	converter" means a device that is incorporated in a motor
13	vehicle's exhaust system and contains a catalyst for converting
14	pollutant gas emissions into less harmful emissions.
15	(3) Theft of a catalytic converter is a class C felony."

- 1 SECTION 2. Section 445-231, Hawaii Revised Statutes, is
- 2 amended by adding a new definition to be appropriately inserted
- 3 and to read as follows:
- 4 ""Catalytic converter" means a device that is incorporated
- 5 in a motor vehicle's exhaust system and contains a catalyst,
- 6 including but not limited to palladium, platinum, and rhodium,
- 7 for converting pollutant gas emissions into less harmful
- 8 emissions."
- 9 SECTION 3. Section 445-233, Hawaii Revised Statutes, is
- 10 amended as follows:
- 11 1. By amending subsection (b) to read:
- "(b) If the scrap presented for purchase is copper,
- 13 palladium, platinum, rhodium, a beer keg, [ex] an urn, or scrap
- 14 catalytic converter from which some or all of the catalyst
- 15 metals have been removed, in whole or in part, the seller shall
- 16 provide a copy of a receipt that describes, with particularity:
- 17 (1) The exact item that is being offered for sale;
- 18 (2) Who issued the receipt;
- 19 (3) The date of sale of the item prior to the item's being
- offered to the scrap dealer; and

- 1 (4) The price, if any, of the item when obtained by the 2 seller."
- 3 2. By amending subsections (d) through (f) to read:
- 4 "(d) If the seller does not provide a copy of the receipt
- 5 or the notarized declaration as required by subsections (b) and
- 6 (c), the scrap dealer shall not purchase the copper, palladium,
- 7 platinum, rhodi<u>um</u>, beer keg, [or] urn, or scrap catalytic
- 8 converter from which some or all of the catalyst metals have
- 9 been removed, in whole or in part, and shall report the
- 10 attempted sale to the police.
- 11 (e) If the scrap dealer purchases any copper, palladium,
- 12 platinum, rhodium, beer keg, [or] urn, or scrap catalytic
- 13 converter from which some or all of the catalyst metals have
- 14 been removed, in whole or in part, the scrap dealer shall take a
- 15 photograph or photographs of all of the [copper, beer keg, or
- 16 urn, purchased items offered for sale.
- 17 (f) The scrap dealer shall also require the seller to
- 18 verify the seller's identity by presenting a valid photo
- 19 identification card or license issued by a federal or state
- 20 government agency authorized to issue valid identification. If
- 21 the scrap being offered for sale is copper, palladium, platinum,

- 1 rhodium, a beer keg, [or] an urn, or a scrap catalytic converter
- 2 from which some or all of the catalyst metals have been removed,
- 3 in whole or in part, the scrap dealer shall:
- 4 (1) Take a photograph of the seller; or
- 5 (2) Make a photocopy of the identification card or license
- 7 SECTION 4. This Act does not affect rights and duties that
- 8 matured, penalties that were incurred, and proceedings that were
- 9 begun before its effective date.
- 10 SECTION 5. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 6. This Act shall take effect upon its approval.

Report Title:

Catalytic Converter; Theft; Penal Code; Class C Felony; Scrap Dealers; Statement

Description:

Establishes the offense of theft of catalytic converter as a class C felony. Defines "catalytic converter." Requires scrap dealers to follow the same requirements regarding a written statement for the purchase of palladium, platinum, rhodium, and a scrap catalytic converter from which some or all of the catalyst metals have been removed as is required for the purchase of copper, beer kegs, and urns.
