A BILL FOR AN ACT

RELATING TO SUSTAINABLE AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the use of cover
- 2 crops, green manure, and compost increases agricultural
- 3 productivity and aligns with the State's integrated
- 4 sustainability goals. Plants used for this purpose, including
- 5 grasses, legumes, and forbs, add nutrients to the soil, act as
- 6 windbreaks, assist with water retention, provide habitats for
- 7 beneficial insects, and help to prevent soil erosion.
- 8 The legislature further finds that it is in the interest of
- 9 the State to incentivize the use of management practices that
- 10 enhance the quality and sustainability of Hawaii's agricultural
- 11 lands.
- 12 Accordingly, the purpose of this Act is to establish and
- 13 appropriate moneys for a cover crop reimbursement pilot program
- 14 to reimburse farming operations in the State for the costs of
- 15 acquiring cover crop seeds, green manure, or compost.
- 16 SECTION 2. (a) The department of agriculture shall
- 17 establish and implement a three-year cover crop reimbursement



- 1 pilot program to reimburse farming operations in the State for
- 2 the costs of acquiring cover crop seeds, green manure, or
- 3 compost.
- 4 (b) Applications for cost reimbursements shall be
- 5 submitted on a form furnished by the department of agriculture
- 6 and shall be accompanied by documentation of the costs of items
- 7 purchased, pursuant to subsection (c); provided that:
- 8 (1) The applicant shall indemnify and hold harmless the
- 9 State and its officers, agents, and employees from all
- 10 claims arising out of or resulting from the cover crop
- seeds, green manure, or compost purchased; and
- 12 (2) The department of agriculture may request that an
- applicant provide additional information for the
- 14 purposes of verifying the volume of cover crop seeds,
- green manure, or compost purchased.
- 16 (c) Applications for reimbursement under the cover crop
- 17 reimbursement pilot program shall be filed for cover crop seeds,
- 18 green manure, and compost purchased within the fiscal year
- 19 immediately preceding the filing and be effective for costs of
- 20 the purchases incurred after June 30, 2022, and before July 1,
- 21 2025. The documentation accompanying the application shall



- 1 include a certification that the amount for which the applicant
- 2 seeks reimbursement is not already covered by other governmental
- 3 cover crop incentive programs, including the United States
- 4 Department of Agriculture, Natural Resources Conservation
- 5 Service's environmental quality incentives program or the
- 6 conservation stewardship program.
- 7 (d) Upon approval, funds shall be disbursed upon approval
- 8 on an annual basis by the department of agriculture to the
- 9 farmer or rancher for up to seventy-five per cent of the costs
- 10 incurred for cover crop seeds, green manure, or compost
- 11 purchased after June 30, 2022, and before July 1, 2025.
- (e) The department of agriculture shall convene a review
- 13 panel comprising knowledgeable representatives from the
- 14 department of agriculture, University of Hawaii college of
- 15 tropical agriculture and human resources, and industry
- 16 organizations to screen and rate applicants on the quality and
- 17 appropriate use of their cover crops and green manure and
- 18 composting practices. The department shall aggregate the total
- 19 reimbursement applications pursuant to this section and
- 20 distribute the available moneys on a ranking scale from highest
- 21 to lowest as determined by the review panel.

- 1 There is established within the department of (f) 2 agriculture a cover crop reimbursement pilot program manager 3 position, which shall be a full-time temporary position exempt 4 from the requirements of chapters 76 and 89, Hawaii Revised 5 The cover crop reimbursement pilot program manager 6 shall receive a salary not exceeding \$50,000 per year. The 7 cover crop reimbursement pilot program manager shall possess a 8 requisite level of knowledge and expertise in the area of 9 program management necessary to carry out the duties of the 10 position. The cover crop reimbursement pilot program manager 11 shall: 12 (1)Facilitate the division and distribution of available 13 costs for reimbursement; and 14 (2) Manage the day-to-day coordination of the cover crop 15 reimbursement pilot program.

 19 (h) The department of agriculture shall submit an interim

Any action taken by the department of agriculture

- 20 report of its findings and recommendations, including any
- 21 proposed legislation, to the legislature no later than twenty

- 1 days prior to the convening of the regular session of 2025 and a
- 2 final report no later than twenty days prior to the convening of
- 3 the regular session of 2026. The report shall include the
- 4 department's recommendation on whether the pilot program should
- 5 be extended, with or without modifications.
- 6 (i) As used in this section:
- 7 "Compost" means a product of a composting process.
- 8 "Compostable materials" includes pre- and post-consumer
- 9 food waste, waste from animal food processing operations, green
- 10 waste, crop residues, and waste from vegetable food processing
- 11 operations and similar materials.
- "Composting process" means a process in which organic
- 13 compostable materials are biologically decomposed under
- 14 controlled conditions to produce a stable humus-like mulch or
- 15 soil amendment, and includes:
- 16 (1) Receipt of materials;
- 17 (2) Primary processing;
- 18 (3) Decomposition activities; and
- 19 (4) Final processing for sale and marketing.
- "Cover crop" and "green manure" mean the plants listed in
- 21 the cover crop and green manure database maintained by the

- 1 University of Hawaii college of tropical agriculture and human
- 2 resources.
- 3 "Farming operation" has the same meaning as in section
- 4 165-2, Hawaii Revised Statutes.
- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2022-2023 for
- 8 the department of agriculture to establish, implement, and
- 9 administer a cover crop reimbursement pilot program; provided
- 10 that up to \$ may be used for the pilot program's
- 11 administrative costs.
- 12 The sum appropriated shall be expended by the department of
- 13 agriculture for the purposes of this Act.
- 14 SECTION 4. This Act shall take effect on July 1, 2022.

Sustainable Agriculture; HDOA; Cover Crop Reimbursement Pilot Program; Appropriation

Description:

Establishes a cover crop reimbursement pilot program to provide up to seventy-five per cent cost reimbursement to farming operations in the State for acquiring cover crop seeds, green manure, or compost. Requires the convening of a review panel to screen and rate applicants on the quality of their cover crop and green manure and composting practices. Establishes a cover crop reimbursement pilot program manager position within the Department of Agriculture to administer the program. Requires a report to the Legislature. Appropriates funds.
