### A BILL FOR AN ACT

RELATING TO EXPUNGEMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 291E, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§291E- First-time offender of operating a vehicle after
- 5 consuming a measurable amount of alcohol for persons under the
- 6 age of twenty-one prior to 1997; expungement. A person
- 7 sentenced prior to July 1, 1997, for a first-time offense of
- 8 operating a vehicle after consuming a measurable amount of
- 9 alcohol while under the age of twenty-one, pursuant to section
- 10 291E-64, and who otherwise meets all the requirements of section
- 11 291E-64, may apply to the court for expungement of the record of
- 12 conviction for the offense. The court shall issue a court order
- 13 to expunge the record of conviction for the offense; provided
- 14 that the person has complied with the terms and conditions set
- 15 by the court. A person granted an expungement of conviction
- 16 under this section shall not be eligible for another expungement
- 17 of conviction under this section or section 291E-64."

2	amended by adding a new section to be appropriately designated

4	"§706- First-time property offender prior to 1997;
5	probation; expungement. A person sentenced prior to July 1,
6	1997, for a first-time property offense, pursuant to section
7	706-622.9, and who otherwise meets all the requirements of
8	section 706-622.9, may apply to the court for expungement of the
9	record of conviction for the property offense. The court shall
10	issue a court order to expunge the record of conviction for the
11	property offense; provided that the person has complied with the
12	terms and conditions set by the court. A person granted an
13	expungement of conviction under this section shall not be
14	eligible for another expungement of conviction under this
15	section or section 706-622.9."
16	SECTION 3. New statutory material is underscored.
17	SECTION 4. This Act shall take effect upon its approval.

### Report Title:

Expungement; Operating a Vehicle After Consuming a Measurable Amount of Alcohol; Property Offenses; Judiciary
