A BILL FOR AN ACT

RELATING TO GIFTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, from time to time, legislators and other state employees accept protocol gifts on 2 behalf of the State or either house of the legislature from 3 foreign officials, federal officers, or state officials from 4 other states. These gifts may symbolize goodwill or strengthen 5 international or national friendships. Failure to accept such a 6 7 gift may cause embarrassment to the donor and the recipient. These gifts may be small tokens, such as a fountain pen or a 8 gift that a state is famous for, or may be larger gifts, such as 9 10 a painting, musical instrument, or commemorative plate. The legislature further finds that, unlike the federal 11 government, where several federal offices and agencies abide by 12 a system for the receipt, valuation, and disposition of gifts to 13 the President of the United States, the treatment of protocol 14 gifts accepted by legislators and state employees on behalf of 15 the State or either house of the legislature from visiting 16 dignitaries is not established under state law. Furthermore, 17 18 because these gifts are not accepted on the legislator's or

- 1 state employee's own behalf, these gifts are not required to be
- 2 reported in the gifts disclosure statement. Many legislators
- 3 and state employees keep an inventory of protocol gifts they
- 4 receive in accordance with rules adopted by the state senate or
- 5 the state house of representatives. However, without a uniform
- 6 set of procedures regarding the custody, inventory, and
- 7 maintenance of these protocol gifts, gifts may be inadvertently
- 8 lost, misplaced, or not reasonably maintained.
- 9 The purpose of this Act is to establish procedures for the
- 10 custody, inventory, and care of protocol gifts received by
- 11 members of either house of the legislature or other state
- 12 employees.
- SECTION 2. Chapter 84, Hawaii Revised Statutes, is amended
- 14 by adding a new section to be appropriately designated and to
- 15 read as follows:
- 16 "§84- Protocol gifts; written record; legislators. (a)
- 17 Upon receipt of a protocol gift from any foreign officials,
- 18 federal officers, or officials from other states by state
- 19 employee or member of either house of the legislature, the
- 20 recipient shall keep a written record of the following:
- 21 (1) A description of the protocol gift;
- 22 (2) The date on which the protocol gift was received;
- 23 (3) The identity of the individual donor,

17	(b)	Each recipient shall exercise reasonable care in the						
18	maintenan	ce of any protocol gift in the recipient's possession						
19	that is l	isted on the written record. All protocol gifts listed

22	gift is in office or employed by the State.

- office holder shall be responsible for exercising
- 4 reasonable care in the maintenance of the protocol

- 6 (2) Be transferred to the state archives; or
- 7 (3) Be transferred to the state foundation on
- 8 culture and the arts.
- 9 The incumbent office holder shall transfer the written record to
- 10 the succeeding office holder, who shall be responsible for
- 11 maintaining the written record thereafter."
- 12 SECTION 3. Section 84-3, Hawaii Revised Statutes, is
- 13 amended by adding a new definition to be appropriately inserted
- 14 and to read as follows:
- ""Protocol gift" means a tangible and nonperishable present
- 16 tendered to or received by a legislator or state employee from
- 17 an individual donor, government agency, entity, or organization
- 18 as a gesture of goodwill and friendship between the institution
- 19 of the gifter and the State."
- 20 SECTION 4. Section 84-11.5, Hawaii Revised Statutes, is
- 21 amended by amending subsection (d) to read as follows:
- 22 "(d) Excluded from the reporting requirements of this
- 23 section are the following:

 15 recipient;
- 16 (6) [Gifts] Non-protocol gifts that, within thirty days

 17 after receipt, are returned to the giver or delivered

 18 to a public body or to a bona fide educational or

 19 charitable organization without the donation being

 20 claimed as a charitable contribution for tax purposes;

 21 and
- 22 (7) Exchanges of approximately equal value on holidays,
 23 [birthday,] birthdays, or special occasions."

Description:

Defines the reporting and disposition requirements for gift received by members of the legislature or employees of the State.

JUSTIFICATION SHEET

DEPARTMENT: ACCOUNTING AND GENERAL SERVICES

TITLE: A BILL FOR AN ACT RELATING TO GIFTS.

PURPOSE: To define reporting and disposition

requirements for protocol gifts received by State employees or members of either house

of the Legislature.

MEANS: Add a new section to chapter 84 and amend

sections 84-3 and 84-11.56, Hawaii Revised

Statutes

JUSTIFICATION: Protocol gifts received by State employees

or members of the Legislature on behalf of the State or its people have important historical and political value far beyond the initial act of gifting. As such, these gifts, as property of the State, should be closely tracked to ensure that they remain accessible to the State when representatives of the original gifting institution return

to Hawaii. Currently, tracking of such protocol gifts is lacking with little to no traceability. When the original recipients of the protocol gifts separate from State service, an irretrievable loss of the

protocol gifts can occur thereby negatively affecting the State's ability to showcase the history of interaction between the State

and original gifting institution.

Impact on the public: Important historic objects gifted to the State by officials, federal officers, or state officials from other states shall continue as a valued asset of the State, available for continued public inspection, and available for display in the future when individuals from the gifting institution visit Hawaii.

Impact on the department and other agencies:
This bill will require that State employees
and members of either house of the

Legislature keep formal records of receipt of protocol gifts, transfer a copy of the list annually to the State Archives, and ensure the continued custody of protocol gifts by the State when the recipient separates from the State.
