The sums hereinabove may be paid to the respective persons, or for the satisfaction or settlement of the 8 9 respectively identified cases, and in several amounts 10 hereinabove set forth or in lesser amounts deemed appropriate, 11 upon checks issued by the comptroller; provided that departments 12 shall obtain the approval of the attorney general before payment 13 of any claim can be made. 14 SECTION 7. Notwithstanding the sums hereinabove stated as 15 interest upon judgments against the State, payment of interest 16 shall be limited to the period from the date of judgment, if 17 applicable, to thirty days after the effective date of this Act, 18 as provided in section 662-8, Hawaii Revised Statutes, for those 19 cases to which the statute applies.

5	application thereof to any person or circumstance is held
6	invalid, the invalidity does not affect other provisions or
7	applications of the Act, which can be given effect without the
8	invalid provision or application, and to this end the provisions
9	of this Act are severable.
