# A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH  
FOR COVID-19 VACCINATIONS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. This Act is recommended by the governor for  
2       immediate passage in accordance with section 9 of article VII of  
3       the Constitution of the State of Hawaii.

4       SECTION 2. Vaccinations are a critical intervention that  
5       dramatically decrease the health impacts of the COVID-19  
6       pandemic. The current COVID-19 omicron variant is significantly  
7       more transmissible than previous variants. Studies have  
8       demonstrated the tremendous importance of vaccinations in both  
9       reducing the severity of illness as well as the transmission of  
10      disease.

11      Current federal funding from the United States Federal  
12      Emergency Management Agency will expire in March 2021.  
13      Additional state funds are needed to support community  
14      vaccination efforts through April, May, and June 2021.

15      Therefore, the purpose of this Act is to make an emergency  
16      appropriation for fiscal year 2021-2022 to provide resources for


1 the department of health and community partners to respond  
2 effectively.

3 SECTION 3. There is appropriated out of the general  
4 revenues of the State of Hawaii the sum of \$12,000,000 or so  
5 much thereof as may be necessary for fiscal year 2021-2022 for  
6 surge-response vaccination activities.

7 The sum appropriated shall be expended by the department of  
8 health for the purposes of this Act.

9 SECTION 4. This Act shall take effect upon its approval.

**SB. NO. 3125**

DEPARTMENT: Health

TITLE: A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH FOR COVID-19 VACCINATIONS.

PURPOSE: Make an emergency appropriation to the Department of Health for fiscal year 2021-2022 for purposes of COVID-19 vaccination.

MEANS: Emergency appropriation.

JUSTIFICATION: The current COVID-19 omicron variant is significantly more transmissible than previous variants. Studies have demonstrated the tremendous importance of vaccinations in both reducing the severity of illness as well as the transmission of disease.

Current federal funding from the United States Federal Emergency Management Agency will expire in March 2021. Additional state funds are needed to support community vaccination efforts through April, May, and June 2021.

Impact on the public: Extend access to COVID-19 vaccinations for the second calendar quarter of 2022.

Impact on the department and other agencies: Allows the Department of Health to respond more effectively to current and future surges of COVID-19 cases. The lack of an emergency appropriation or other source of funds will jeopardize and diminish Hawaii's vaccination rate.

GENERAL FUND: \$12,000,000.
