BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 386, Hawaii Revised Statutes, is 2 amended by amending the title of part V, subpart C to read as follows: 3 "C. PUBLIC BOARD MEMBERS, RESERVE POLICE OFFICERS, POLICE 4 5 CHAPLAINS, VOLUNTEER FIREFIGHTERS, VOLUNTEER BOATING ENFORCEMENT OFFICERS, [AND] VOLUNTEER CONSERVATION AND RESOURCES 6 7 ENFORCEMENT OFFICERS, AND RESERVE PUBLIC SAFETY LAW ENFORCEMENT 8 OFFICERS" 9 SECTION 2. Section 386-181, Hawaii Revised Statutes, is 10 amended to read as follows: 11 "§386-181 Generally. (a) As used in this section: 12 "Police chaplain" means a member of an authorized 13 chaplaincy program of a county police department who performs services in a voluntary and unpaid capacity under the authorized 14 15 direction of an officer of the department. "Public board" means a governmental body, regardless of its 16 designation, duly created under authority vested by law for the 17

"Reserve police officer" means a member of an authorized 3 reserve force of a county police department who performs 4 services in a voluntary and unpaid capacity under the authorized 5 6 direction of an officer of the department. 7 "Reserve public safety law enforcement officer" means a 8 member of the authorized volunteer law enforcement force of the 9 department of public safety who performs services in a voluntary 10 and unpaid capacity under the authorized direction of an officer 11 of the department of public safety. 12 "Sheriffs' chaplain" means a member of an authorized chaplaincy program of the department of public safety who 13 performs functions similar to a police chaplain in a voluntary 14 15 and unpaid capacity for the sheriff division. 16 "Volunteer boating enforcement officer" means a member of 17 the authorized volunteer enforcement force of the harbors division, department of transportation, who performs services in 18 19 a voluntary and unpaid capacity under the authorized direction of an officer of the department. 20 21 "Volunteer conservation and resources enforcement officer"

means a member of the authorized volunteer enforcement force of

Workers' Compensation Law

Description:

Amends the title of chapter 386, part V, subpart C, Hawaii Revised Statutes (HRS), to add reserve public safety law enforcement officers, and amends section 386-181, HRS, to include reserve public safety law enforcement officers to the list of volunteer occupations covered under the workers' compensation law. Allows reserve public safety law enforcement officers who are injured under the conditions specified in section 386-3, HRS, to receive workers' compensation. Adds reserve public safety law enforcement officers to the list of volunteers who are covered under the conditions for computing average weekly wages.

PURPOSE:

To add reserve public safety law enforcement officers to the list of volunteer occupations covered under the workers' compensation law. The addition of reserve public safety law enforcement officers to the list of covered volunteer occupations under chapter 386, Hawaii Revised Statutes (HRS), will enable reserve public safety law enforcement officers who are injured on the

job to receive workers' compensation

coverage and include reserve public safety

law enforcement officers under the

provisions for computing average weekly

wages.

MEANS:

Amend the title of chapter 386, part V, subpart C, HRS, and section 386-181, HRS.

JUSTIFICATION:

The passage of this bill will enable the department of public safety to more easily augment its cadre of reserve volunteer law enforcement officers to enhance public safety.

Impact on the public: Increased law
enforcement services to better protect the
community.

Impact on the department and other agencies:
Provide workers' compensation coverage for
volunteer reserve public safety law
enforcement officers to encourage
