#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 266-2.3, Hawaii Revised Statutes, is
 repealed.

JUSTIFICATION:	The Department of Transportation seeks to repeal these sections of the Hawaii Revised Statutes for the following reasons:
	Section 266-2.3, Kewalo basin use permit; Honolulu harbor use permit; portability - oversight of Kewalo basin is under the purview of the Hawaii Community Development Authority (HCDA), and the statutes should be repealed to reflect that shared permitting and expense items are wholly with the HCDA.
	Section 266-22, Maintenance of fire boat - The Department of Transportation no longer owns any fireboats.
