A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, under the
- 2 governor's emergency proclamations related to homelessness
- 3 issued on October 16, 2015, and December 6, 2018, respectively,
- 4 and the supplemental proclamations thereto, the State and
- 5 counties, in partnership with developers and nonprofit
- 6 organizations, created portable homes. These homes, commonly
- 7 referred to as tiny homes or kauhale, were exempted from county
- 8 building permits and other restrictions. The semi-permanent
- 9 tiny homes or kauhale are a pathway out of homelessness for
- 10 working residents who cannot afford market rentals. The
- 11 legislature further finds that the final supplemental
- 12 proclamation to the governor's 2018 emergency proclamation
- 13 expired on February 14, 2020.
- 14 The legislature also finds that, according to a January 10,
- 15 2022, Honolulu Star-Advertiser article, the below-market rent
- 16 for a studio apartment is \$1,320 for a three hundred twenty-six
- 17 square foot unit. However, a family with parents working full-



- 1 time and earning the minimum wage of \$10.10 per hour cannot even
- 2 afford such a small studio because it is over fifty per cent of
- 3 their net take home pay. Additionally, for those classified as
- 4 low-income, which is commonly defined as eighty per cent of the
- 5 area median income, or \$67,680 for an individual and \$77,360 for
- 6 a couple in the City and County of Honolulu, existing housing is
- 7 far from affordable. These low-income individuals, many of whom
- 8 work in the tourism industry, are usually left with few housing
- 9 options and thus, portable home villages like Kahauiki Village
- 10 on Sand Island are filled with low-income working families.
- 11 The legislature finds that continued support for tiny homes
- 12 or kauhale is needed to ensure that homes for low-income working
- 13 families are available as a pathway out of homelessness until
- 14 the market creates permanent homes for them.
- The purpose of this Act is to:
- 16 (1) Ensure the continuity and existence of the low-income
- tiny home projects developed pursuant to the
- governor's 2015 or 2018 emergency proclamations
- related to homelessness or their supplemental
- 20 proclamations by exempting the projects from certain

Establishes the Low-Income Tiny Home Village Pilot Program to provide shelter and certain services to low-income and homeless individuals. Effective 12/31/2050. (SD1)
