A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII OPTIONAL RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 88-8, Hawaii Revised Statutes, is
- 2 amended as follows:
- 3 1. By amending subsection (a) to read:
- 4 "(a) Notwithstanding any other law to the contrary, the
- 5 board of regents may establish without regard to the public
- 6 notice or public hearing requirements of chapter 91, a
- 7 retirement system separate from the state employees' retirement
- 8 system to provide retirement allowances and other benefits for
- 9 University of Hawaii employees who are:
- 10 (1) Members of bargaining [unit] units (7)[+] or (8); or
- 11 (2) Other employees of the University of Hawaii or the
- 12 community college system who are excluded from
- bargaining [unit] units (7) or (8) pursuant to chapter
- **14** 89."
- 2. By amending subsections (f) through (h) to read:

1	"(f) Any member of the state employees' retirement system
2	when the optional retirement system of the University of Hawaii
3	is established who is also:
4	(1) A member of bargaining unit (7); $[\Theta r]$
5	(2) A member of bargaining unit (8); or
6	$[\frac{(2)}{(3)}]$ Other employees of the University of Hawaii or
7	the community college system who are excluded from
8	bargaining [unit] units (7) or (8) pursuant to chapter
9	89,
10	shall remain a member of the state employees' retirement system
11	unless the person elects in writing on a form prescribed by the
12	board of regents to terminate the person's membership. The form
13	shall be submitted to the state employees' retirement system no
14	later than ninety days after the establishment of the optional
15	retirement system of the University of Hawaii.
16	(g) Any person hired after the establishment of the
17	optional retirement system of the University of Hawaii who is:
18	(1) A member of bargaining unit (7); [or]
19	(2) A member of bargaining unit (8); or
20	$\left[\frac{(2)}{(3)}\right]$ Other employees of the University of Hawaii or
21	the community college system who are excluded from

3	shall elect to be a member of the state employees' retirement
4	system or the optional retirement system of the University of
5	Hawaii. Upon an election the person may not transfer from one
6	system to the other.
7	(h) Notwithstanding any other law to the contrary,
8	retirement benefits for the optional retirement system of the
9	University of Hawaii shall be a subject of collective bargaining
10	negotiations for bargaining [unit] units (7) [-] and (8)."
11	SECTION 2. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 3. This Act shall take effect upon its approval.
