## A BILL FOR AN ACT

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that children's privacy
 rights prevail over the public's right to know. Therefore, the
 purpose of this Act is to amend the sunshine law to exempt
 minors from being required to state their presence in public
 meetings.

6 SECTION 2. Section 92-3.7, Hawaii Revised Statutes, is
7 amended by amending its title and subsection (a) to read as
8 follows:

9 "[4] §92-3.7[+] Remote meeting by interactive conference technology; notice; quorum. (a) A board may hold a remote 10 11 meeting by interactive conference technology; provided that the interactive conference technology used by the board allows 12 audiovisual interaction among all members of the board 13 14 participating in the meeting and all members of the public 15 attending the meeting, except as otherwise provided under this section; provided further that there is at least one meeting 16 location that is open to the public and has an audiovisual 17

A board holding a remote meeting pursuant to this section shall not be required to allow members of the public to 2 join board members in person at nonpublic locations where board 3 members are physically present or to identify those locations in 4 5 the notice required by section 92-7; provided that at the meeting, each board member shall state who, if anyone, excluding 6 7 any person under the age of eighteen, is present at the nonpublic location with the member. The notice required by 8 9 section 92-7 shall: 10 List at least one meeting location that is open to the (1)public that shall have an audiovisual connection; and 11 12 (2) Inform members of the public how to contemporaneously: 13 (A) Remotely view the video and audio of the meeting 14 through internet streaming or other means; and (B) Provide remote oral testimony in a manner that 15 16 allows board members and other meeting 17 participants to hear the testimony, whether 18 through an internet link, a telephone conference, 19 or other means. The board may provide additional locations open for public 20

21 participation. The notice required by section 92-7 shall list

any additional locations open for public participation and 1 specify, in the event an additional location loses its 2 3 audiovisual connection to the remote meeting, whether the 4 meeting will continue without that location or will be 5 automatically recessed to restore communication as provided in 6 subsection (c)." 7 SECTION 3. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 8 9 SECTION 4. This Act shall take effect upon its approval. 10
