BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 304A-112, Hawaii Revised Statutes, is
amended to read as follows:

"[4] §304A-112[4] Contracts for services provided by the 3 research corporation of the University of Hawaii. 4 (a) 5 Notwithstanding any law to the contrary, when the university determines that neither the university nor another state agency 6 can more effectively or efficiently accomplish the purposes of 7 the sponsored research and training activities, the university 8 9 shall contract with the research corporation of the University 10 of Hawaii established under section [+]304A-3001[+] to provide 11 management and other services as described in subsection (b) to 12 support the university's research and training activities. 13 Contracts by the university with the research corporation pursuant to this section shall be limited to sponsored research 14 and training projects; except that [university projects 15 supported by] funds appropriated by the legislature may also be 16

Description:
