A BILL FOR AN ACT

RELATING TO AIRPORTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. (a) There is established an airport advisory 1 working group in the department of transportation for 2 3 administrative purposes. The duties of the airport advisory working group shall 4 be to advise the department of transportation airports division 5 regarding airport design and construction projects to achieve 6 the following goals: 7 Prioritizing the user experience of the airports; 8 (2) Reflecting the local culture, environment, and sense 9 of place; and 10 Sharing a narrative of the history of Hawaii and its 11 (3) 12 values. 13 To achieve these goals, the airport advisory working group shall: 14 (1) Establish general design themes, goals, and direction 15 16 for airports;

- 7 The sum appropriated shall be expended by the department of
