A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE X, SECTION 6, OF THE CONSTITUTION OF THE STATE OF HAWAII TO ESTABLISH A PRESIDENT OF COMMUNITY COLLEGES OF THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose an
- 2 amendment to article X, section 6, of the Constitution of the
- 3 State of Hawaii to establish the position of president of
- 4 community colleges who shall be appointed by the board of
- 5 regents of the University of Hawaii.
- 6 SECTION 2. Article X, section 6, of the constitution of
- 7 the State of Hawaii is amended to read as follows:
- 8 "BOARD OF REGENTS; POWERS
- 9 Section 6. There shall be a board of regents of the
- 10 University of Hawaii, the members of which shall be nominated
- 11 and, by and with the advice and consent of the senate, appointed
- 12 by the governor from pools of qualified candidates presented to
- 13 the governor by the candidate advisory council for the board of
- 14 regents of the University of Hawaii, as provided by law. At
- 15 least part of the membership of the board shall represent
- 16 geographic subdivisions of the State. The board shall have the

- 1 power to formulate policy [-] and to exercise control over the
- 2 university through its executive officer, the president of the
- 3 university, who shall be appointed by the board[-]; provided
- 4 that for aspects of the university that involve the community
- 5 colleges, the board shall have the power to formulate policy and
- 6 to exercise control over the community colleges through its
- 7 executive officer, the president of community colleges, who
- 8 shall be appointed by the board. The board shall also have
- 9 exclusive jurisdiction over the internal structure, management,
- 10 and operation of the university. This section shall not limit
- 11 the power of the legislature to enact laws of statewide concern.
- 12 The legislature shall have the exclusive jurisdiction to
- 13 identify laws of statewide concern."
- 14 SECTION 3. The question to be printed on the ballot shall
- 15 be as follows:
- 16 "Shall the Constitution of the State of Hawaii be
- amended to establish the position of president of community
- 18 colleges of the University of Hawaii who shall be appointed
- by the Board of Regents of the University of Hawaii?"
- 20 SECTION 4. New constitutional material is underscored.
