# A BILL FOR AN ACT

---

RELATING TO THE STATE BUILDING CODE COUNCIL.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that Act 82, Session Laws  
2 of Hawaii 2007, codified in part II of chapter 107, Hawaii  
3 Revised Statutes, established the state building code council to  
4 adopt a uniform set of statewide building codes applicable to  
5 one- and two-family dwellings and all other residential,  
6 commercial, industrial, and state buildings to facilitate the  
7 application of consistent standards by building owners,  
8 designers, contractors, and code enforcers within the State.

9       The legislature further finds that the state building code  
10 council comprises four government officials, two private design  
11 professionals, and one representative from either the General  
12 Contractors Association of Hawaii or the Building Industry  
13 Association of Hawaii. Since its formation, the state building  
14 code council has struggled with limited funding and staffing  
15 support.

16       The legislature further finds that with funding and  
17 permanent staff, the state building code council can better



1 update and adopt commercial and residential codes, and meet the  
2 intent of Act 82, Session Laws of Hawaii 2007, which was to  
3 adopt a uniform set of statewide building codes.

4 The purpose of this Act is to appropriate funds for the  
5 state building code council to hire authorized staff.

6 SECTION 2. There is appropriated out of the general  
7 revenues of the State of Hawaii the sum of \$400,000 or so much  
8 thereof as may be necessary for fiscal year 2022-2023 to  
9 establish one full-time equivalent (1.0 FTE) program director  
10 position and one full-time equivalent (1.0 FTE) staff member  
11 position, and for employee training, materials and supplies,  
12 other costs associated with the state building code council, and  
13 any costs necessary to establish a full-time state building code  
14 council office.

15 The sum appropriated shall be expended by the department of  
16 accounting and general services for the purposes of this Act.

17 SECTION 3. This Act shall take effect on July 1, 2022.
